# PROJECT NAME

**Remote Infrared Audible Signs** 

#### PROPOSED ACTION

Authorizes the chief executive officer to execute a two-year contract with an additional one-year option to extend with Talking Signs Services, Inc. to purchase, install, and maintain static equipment and infrastructure for the Remote Infrared Audible Signs project in the amount of \$2,152,621, with a contract option for vehicle components in the amount of \$50,000 for a total authorized contract amount not to exceed \$2,202,621.

# KEY FEATURES of PROPOSED ACTION

- In August 2006, Sound Transit was awarded a \$1,980,000 grant from the Federal Transit Administration to conduct a demonstration project exploring the use of remote infrared audible signs in multimodal facilities. Sound Transit was the sole recipient of this grant.
- The grant requires a report to the Federal Transit Administration on the project by September 2009. This action is needed to satisfy the terms of the grant.
- The Remote Infrared Audible Signs (RIAS) project includes purchase, installation and maintenance of all components for necessary for operation of the system at selected Sound Transit Facilities.
- RIAS is a system of infrared transmitters and receivers designed to aid persons who are blind, partially sighted or who have developmental disabilities. The system guides users through the built in environment in transit facilities or along paths of travel on public streets and intersections.

- The contract defines a scope of work, including purchase, installation and testing of all system components, maintenance of equipment, development of a vehicle unit to integrate the system.
- The contract provides for a two-year term with one additional one-year option to extend. The requested contract amount is for all three years of the contract.

# **BUDGET and FINANCIAL PLAN DISCUSSION**

The proposed action would authorize the execution of a contract to procure and install equipment using Remote Infrared Audible Sign technology as well as the initial maintenance contracts to maintain this equipment beyond the warranty period. The funding for this contract would come from two sources:

**Talking Signs capital project (#744):** The procurement and installation costs associated with this contract would total \$2,202,621. These elements would be funded by the Talking Signs capital project, which has a lifetime project budget of \$2,379,075. Existing commitments against this project total \$174,447. The proposed action would create a phase level shortfall in the construction phase of this project. Per Sound Transit budget policies, such phase level shortfalls are resolved during the next budget cycle if sufficient project budget is available to fund this shortfall. The agency administration phase of this project has sufficient budget capacity to fund this shortfall.

**Maintenance of Equipment:** The maintenance portion of this contract is expected to total approximately \$95,000 over the life of the contract. None of this expense is expected to occur prior to 2009 and all operating expense elements will be included in future Accessible Services budgets. These items are included in the long-term financial plan.
