## PROJECT NAME

Sounder Commuter Rail Fleet Program

## PROPOSED ACTION

Authorizes the chief executive officer to execute a sole source contract with Rail Systems, Inc. to provide locomotive automatic engine start/stop system application, equipment and installation services for the Sounder Fleet Program in the amount of \$209,633, with a 10% contingency of \$20,963, for a total authorized contract amount not to exceed \$230,596.

## KEY FEATURES of PROPOSED ACTION

- The proposed action will authorize the purchase and installation of the Automatic Engine Start/Stop (AESS) system for the eleven Sounder locomotives.
- AESS will allow Sounder locomotives to save fuel by automatically shutting down the engine when conditions warrant.
- Implementation of AESS will provide significant fuel savings as well as environmental benefits of reduced emissions and noise reduction.
- The Puget Sound Clean Air Agency is contributing \$100,000 in grant funding to this project as it will contribute toward the objective of reducing the consumption of fuel with its associated reduction in pollution and greenhouse gas emissions.

## **BUDGET IMPACT SUMMARY**

There is no action outside of the Board-adopted budget; there are no contingency funds required, no subarea impacts, or funding required from other parties other than what is already assumed in the financial plan.

# **BUDGET and FINANCIAL PLAN DISCUSSION**

The proposed action would authorize the acquisition and installation of automatic engine start/stop equipment in the amount of \$230,596. This item is a capital cost and was included in the 2008 Sounder fleet program budget (project #702).

The Puget Sound Clean Air Agency has designated \$100,000 of grant funding for this Sounder project. The grant will cover nearly half the cost to implement the program.

#### BUDGET TABLE

The Sounder Fleet Program (#702) was included in the Adopted 2008 Budget on page 72 of the budget book. The impacts of the proposed action on the project budget are illustrated below:

## PROJECT DESCRIPTION and BACKGROUND for PROPOSED ACTION

As part of the Sounder Operations effort to maximize environmental performance by adopting sustainable business practices, several initiatives are being pursued to achieve our objectives. They include initiatives such as installing wayside power at the layover facilities, replacing head end power engines with the environmentally friendly Tier 2 engines, and monitoring the application within the industry of bio-fuel technologies. Recent discussions with industry peers and our manufacturer's representative have provided a confirmation that the opportunity with the greatest return will be to take advantage of recent technology advances to reduce engine idling time through the use of an Automatic Engine Start/Stop (AESS) system provided by Rail Systems, Inc (RSI).

AESS is a system which reduces idling time by intelligently powering down and restarting the locomotive diesel engine if necessary, thus saving fuel and reducing emissions. The system monitors the overall condition of the locomotive by assessing certain parameters such as outside air temperature, engine water temperature, air brake pressure, and battery condition. Once the system has identified that conditions are proper for shut down and battery health is viable for restart, it will automatically power down the locomotive. If conditions deteriorate and the locomotive is at risk of not restarting with any of these parameters being outside of acceptable, the system will automatically restart the locomotive.

This action will advance Sound Transit's objectives in reducing impacts to the environment in conducting business. Estimates of the annual benefits from this action at Sounder full build-out are summarized in the table below:

In addition to the cost and fuel savings issues, it is important to point out that noise pollution will be greatly reduced in the areas of locomotive layover, with a 34% estimated reduction in engine idling time. It should also be noted that because the engine will be running less, there will be corresponding life cycle cost savings from a reduction in the hours of operation.

# CONSEQUENCES of DELAY

Significant cost savings will be achieved with this program; a delay in its implementation will result in a delay in the benefits received. The Puget Sound Clean Air Agency is granting Sound Transit \$100,000 in funding for this project, and would like expenditures to begin by June 2008.

#### Background:

This action will advance Sound Transit's objectives in reducing impacts to the environment in conducting business. Estimates of the annual benefits from this action at Sounder full build-out are summarized in the table below:
