PROPOSED ACTION

Authorizes the chief executive officer to execute a contract amendment with Parametrix, Inc., to provide engineering and environmental services for Phase 2 and 3 of the Puyallup Station Access Improvement Project and the Sumner Access Improvement Project in amount of \$3,707,155, with a 10% contingency of \$ 370,715 totaling \$4,077,870, for a total authorized contract amount not to exceed \$4,963,021.

KEY FEATURES SUMMARY

- This action amends the consultant services contract Parametrix, Inc., to authorize Phase 2 and 3 of project development.
- Phase 2 includes the preparation of the appropriate environmental documents to comply with NEPA and SEPA and conceptual engineering for the Preferred Puyallup and Sumner Station access improvements; Phase 3 includes preliminary engineering of the preferred Sumner and Puyallup Station access improvements.
- The original contract with Parametrix, Inc., included an option to negotiate the scope and cost for completion of Phase 2 and 3 of the project. Parametrix has satisfactorily completed Phase 1 and authorization is sought to proceed to Phase 2 and Phase 3.
- Phase 2 is expected to take approximately 6 months and be completed by early 2015.
- Phase 3 is expected to take approximately 12 months and to be completed by early 2016.

BACKGROUND

Sounder service between Sumner and Seattle continues to experience growth in demand. The Sumner Station parking lots operate at or above capacity daily. Sumner community members are asking Sound Transit to better manage available parking at their stations, and the impact to local streets and downtowns associated with expanded parking near commuter rail stations.

In November 2008, the voter-approved ST2 Plan included funding for access improvements to the Sumner Sound Station. During the process of refining the projects included in the ST2 plan, the ST Board responded to community concerns by calling for a Sounder Access and Demand Study. The Study evaluated potential access improvements to eight existing Sounder stations including Sumner. The study provided a range of potential access improvement projects that Sound Transit could implement in full or in part, that would allow riders to use alternative modes of travel to the Sumner Station.

The Sumner Station Access Improvement Project builds on the results of The Sounder Station Access and Demand Study. Phase 1 of the project further studied parking, traffic, pedestrian and bicycle access improvements that could be made to improve rider access to the Sumner Station. The study performed under Phase 1 will inform the ST Board's identification and selection, for each station by a separate and concurrent board action, of a comprehensive program of specific station access improvements for advancement to Phases 2 and 3 to be performed under this contract amendment by Parametrix.

Phase 2 includes the preparation of the appropriate environmental documents to comply with NEPA and SEPA and conceptual engineering for the Preferred Puyallup and Sumner Station access improvements; Phase 3 includes preliminary engineering of the preferred Sumner and Puyallup Station access improvements.

The original contract with Parametrix, Inc. includes the ability to amend the contract and for Phase 2 and 3 of the project, subject to consultant performance and ST Board approval of a contract amendment. Parametrix, Inc. has satisfactorily completed Phase 1 and was invited to negotiate the scope of work and cost for Phase 2 and Phase 3. This contract amendment approves the Phase 2 and 3 consultant services scope of work and adds funds to complete the work.

FISCAL INFORMATION

The amended Lifetime project budget for Puyallup and Sumner Station Improvements, as shown in the 2014 TIP is \$3,547,000 and \$6,472,000 respectively.

Within that amount, a total of \$4,077,870, including 10% contract contingency has been set aside in the Preliminary Engineering phase. The contract is shared equally between both projects and the proposed action would commit \$2,038,935 to this line item for each project, leaving a remaining balance of:

- \$198,489.48 in Puyallup Station Improvement Project Preliminary Engineering phase and,
- \$203,489.51 in Sumner Station Improvement Project Preliminary Engineering phase.

This action is within the adopted budget and sufficient monies remain after approval of this action to fund the remaining work in the Preliminary Engineering phase as contained in the current cost estimates.
