



## Motion No. M2022-06

A motion of the Board of the Central Puget Sound Regional Transit Authority updating committee chairs, vice chairs and members for 2022.

### Background

The committees of the Sound Transit Board are the Executive Committee, the Finance and Audit Committee, the Rider Experience and Operations Committee, and the System Expansion Committee.

In November 2021, the Board approved Motion No. M2021-70, appointing committee members and chairs for 2021. Since November 2021, Board members Paul Roberts, Jenny Durkan, and Nicola Smith have left the Board, and Everett Mayor Cassie Franklin was confirmed as a Sound Transit Board member by the Snohomish County Council. On January 25, 2021, Seattle Mayor Bruce Harrell was confirmed as a Sound Transit Board member by the King County Council.


