



## Motion No. M2024-10

A motion of the Board of the Central Puget Sound Regional Transit Authority updating committee members and establishing committee meeting schedules for 2024.

### Background

The committees of the Sound Transit Board are the Executive Committee, the Finance and Audit Committee, the Rider Experience and Operations Committee, and the System Expansion Committee.

In January 2023, the Board approved Motion No. M2023-09, appointing committee members and chairs for 2023-2024. At the end of December 2023, Board members David Baker, Debora Juarez, Kent Keel, and Joe McDermott left the Board. On January 16, 2024, Redmond Mayor Angela Birney, Seattle Councilmember Dan Strauss and King County Council Vice Chair Girmay Zahilay were confirmed as Sound Transit Board members by the King County Council. On February 13, 2024, Puyallup Mayor Jim Kastama was confirmed as a Sound Transit Board member by the Pierce County Council.

This action will update committee chairs and members for 2024 to coincide with the current Board Chair and Vice Chair terms.

This action will also establish a new regular schedule for the Finance and Audit Committee and confirm the regular meeting schedules for the remaining Sound Transit Board committees. The committees will meet based on their regular schedule unless directed by the committee chair or Board administrator or designee upon written notice to the committee members. When a regular committee meeting falls on a legal holiday, the committee meeting is held on the next business day unless rescheduled or canceled.
