## **Sound Transit 3 Plan Program Overview**

#### **Projects**

**ST3 Planning:** The basis for both Sound Move and Sound Transit 2 (ST2) initiatives approved by the voters in 1996 and 2008 respectively was a regional long-range transit improvement plan. In association with the ST3 High Capacity Studies (HCT) currently being initiated, the Board of Directors has also authorized the completion of an update to the Long Range Plan and a programmatic Environmental Impact Statement (EIS) on plan elements. The Long Range Plan and the EIS were completed by December 2014.

**Long Range Plan and Plan-level Supplemental EIS:** The basis for both Sound Move and Sound Transit 2 (ST2) initiatives approved by the voters in 1996 and 2008 respectively was a regional long-range transit improvement plan. The Board of Directors has authorized the completion of an update to the Long Range Plan and a Plan-level Supplemental Environmental Impact Statement (SEIS) on plan elements. The updated Long-Range Plan was adopted by the Sound Transit Board in December 2014.

**System Planning:** In 2015, the Sound Transit Board initiated the process to shape a Sound Transit 3 (ST3) ballot measures and identify further transit expansions for voter consideration in November 2016.






## Sound Transit 3 Plan Long Range Plan and Plan-level Supplemental EIS
