Link was slightly outside the quarterly target for boarding performance goals but grew positively versus last year. Headway performance was above target and better than last year.

The minimal growth in average weekday boardings at SeaTac Airport station is attributed to the station no longer being the southern terminus. Many boardings that were previously seen at TIBS and SeaTac are now occurring farther south at Angle Lake. However, that trend is expected to slow down as parking at Angle Lake is at capacity.

Total Sound Transit ridership increased by 3.1% during the first quarter of 2018 compared to the same period in 2017. ST Express and Tacoma Link boardings decreased slightly versus last year, while Sounder and Link saw healthy ridership growth. System-wide average weekday boardings increased by 3.3% compared to the first guarter of 2017.

ST Express bus ridership decreased slightly by 1.6% compared to the first quarter of 2017. Average weekday boardings came to 61,976, which was a slight decrease versus the same quarter of 2017. Average weekday boardings of Sound Transit's busiest routes, Route 545 (Redmond-Seattle) and Route 550 (Bellevue-Seattle), decreased compared to last year. This decline likely related to park-and-ride closures due to East Link contruction, and accounts for the entire decline in ST Express ridership.

Sounder ridership and average weekday boardings increased by 8.3% and 8.7%, respectively. Average weekday boardings on the South line increased by 9.4% and ridership on the North line increased by 2.6%. Ridership growth on the South line was attributed to the two new round trips added in the September 2017 service change.

Tacoma Link ridership decreased slightly by 1.6%, or 4K, compared to the first quarter of 2017. Average weekday boardings increased marginally by 0.1% compared to the same quarter last year. The total ridership decline was related to lower weekend ridership during special events.

Link light rail ridership grew 6.4% compared to the first quarter of 2017. Average weekday boardings were 70,306, a 6.9% increase compared to the same period last year. As the region continues to grow, Link is perceived to be a better choice for commuting.

Paratransit ridership services increased by 9.1% for the first quarter of 2018. Paratransit service is provided along the Link corridor under contract with King County Metro.

ST Express on-time performance and percentage of scheduled trips operated were above target levels. However, overcrowding and traffic congestion continue to negatively impact customer experience. ST Express met the target for preventable accidents per 100K platform miles. The metrics show significant improvement compared to the prior year. Staff and partners continue to work together to identify trends and implement changes to reduce preventable accidents, with a focus on safety as the highest priority.

The Overlake Park and Ride (ST) and the South Bellevue Park and Ride (KCM) closed in May in 2017 for East Link construction. The two closures account for the entire drop in ST Express ridership compared to last year. Despite the closures, routes 550 (Bellevue-Seattle) and 545 (Redmond-Seattle) remain Sound Transit's busiest routes.

Sounder on-time performance in the first quarter of 2018 was impacted by a BNSF south-line tie replacement and undercutting program in February. Also in that same month, freight interference exceeded average as freight volumes were at record levels. Percentage of scheduled trips operated in the quarter was below target due to blocking landslides that cancelled 36 trips in February.
