





## G. Present and Reasonably Foreseeable Actions

Appendix G, Present and Reasonably Foreseeable Actions, provides additional details on the actions considered in analysis presented in Chapter 5, Cumulative Impacts, of the Draft EIS. The analysis considers the potential cumulative long-term impacts of TDLE in conjunction with past, present, and reasonably foreseeable actions. These actions include, but are not limited to activities that have been proposed in comprehensive/management/budget plans or have been submitted as a part of a permitting process. The actions also include larger public projects that often have development documentation available and private projects where development information may be limited or not publicly available.




#### FIGURE G-1 Present and Reasonably Forseeable Actions Federal Way Segment


### FIGURE G-2 Present and Reasonably Forseeable Actions South Federal Way Segment




