



FIGURE J5.1-1 Previous Cultural Surveys within the APE, Federal Way (Federal Way Segment) Tacoma Dome Link Extension





FIGURE J5.1-4 Previous Cultural Surveys within the APE, Tacoma (Tacoma Segment) Tacoma Dome Link Extension



PLAN AND PROCEDURES FOR THE INADVERTENT DISCOVERY OF ARCHAEOLOGICAL RESOURCES AND HUMAN SKELETAL REMAINS

1. INTRODUCTION

Engineering and planning for the Tacoma Dome Link Extension (TDLE) is in process. This project is an approximately 10-mile light rail extension from just south of the Federal Way Transit Center in Federal Way to the vicinity of the Tacoma Dome in Tacoma, Washington.

Archaeological investigations are a supporting element for the TDLE environmental review process and Section 106 compliance. Archaeological survey is proposed to take place throughout the TDLE area of potential effect (APE) within areas of anticipated ground disturbance and will include up to 930 shovel probes and up to 40 archaeological bores.

This Inadvertent Discovery Plan (IDP) outlines the procedures to be implemented if archaeological resources or human remains are encountered during archaeological fieldwork.

2. ARCHAEOLOGICAL FIND DOCUMENTATION PROCEDURES

The discovery of archaeological resources may require notification to the Federal Transit Administration (FTA) as the lead federal agency in charge of compliance with Section 106 of the National Historic Preservation Act (Section 106). Notifications to Section 106 consulting parties (e.g., the State Historic Preservation Officer [SHPO] and affected tribes) may also be needed.

While FTA is the lead federal agency, Sound Transit is the project proponent and oversees the implementation of the IDP. These agencies will work to ensure successful consultation with SHPO and tribes, proper documentation, and subsequent avoidance or treatment of any archaeological resource that is eligible for listing in the National Register of Historic Places (NRHP) following procedures outlined below.

- 1. If an Archaeological Technician¹, under the supervision of the Project Archaeologist (see Section 5.3) encounters an archaeological resource or suspected archaeological resource (the Find) work is required to be halted in the location of the Find. The Find and its immediate surroundings must be protected.
- 2. The Project Archaeologist will evaluate the Find to assess if it is archaeological.
 - a. If the Find is not archaeological, the discovery shall be documented in the daily field notes and work may resume.

¹ Archaeological Technician is defined here as an archaeologist working under the direction and supervision of the Project Archaeologist. Archaeological Technicians are not identified in the contact list below.

- 3. If the Find is archaeological, the Project Archaeologist shall inspect the Find to determine if it is a resource that is potentially eligible for listing in the NRHP. Such potentially eligible archaeological resources are outlined in Section 3 and include all objects that are associated with Native American use of a landscape or those that were produced by Native Americans.
 - a. If the Find is not potentially eligible it shall be documented in a memorandum describing the Find with an eligibility evaluation and an accompanying Washington State Archaeological Inventory Form, per SHPO guidance on Cultural Resources Reporting in Washington State. This eligibility evaluation shall be communicated to Sound Transit's Cultural Resources Program Manager at the end of the working day when the Find is made. The accompanying memo and Washington State Archaeological Inventory Form will be submitted to Sound Transit within one week of the Find.
- 4. If the Find is potentially eligible for listing in the NRHP, the Project Archaeologist shall secure the area, generally within 30 feet, to ensure that the Find is not disturbed.
- 5. If the Find is potentially eligible for listing in the NRHP, the Project Archaeologist shall contact Sound Transit's Cultural Resources Program Manager after securing the area around the Find. The Project Archaeologist shall then make a recommendation to Sound Transit's Cultural Resources Program Manager regarding NRHP eligibility of the Find.
- Sound Transit's Cultural Resources Program Manager shall then forward this recommendation to FTA and then the State Historic Preservation Officer (SHPO) at the direction of FTA.
- 7. A formal determination of NRHP eligibility and concurrence shall come from FTA and SHPO, respectively. This Consultation on eligibility shall also include a determination of effects from FTA vis-à-vis the Find.
- 8. FTA shall notify Affected Tribes of the determinations of eligibility and effects and, as appropriate, engage in Consultation to determine the appropriate course of action (e.g, avoid, minimize, or mitigate any potential adverse effects). SHPO shall also be included in this Consultation process.
- 9. During Steps 1-8 no additional ground disturbing work, including archaeological investigations shall occur within 50 feet of the Find without FTA and SHPO's written authorization (email is acceptable).

3. RECOGNIZING ARCHAEOLOGICAL RESOURCES

A cultural resource is an item of historical, traditional, and/or cultural importance, broad categories of examples include:

- An accumulation of shell (shell midden) with associated bone, stone, antler or wood artifacts, burned rocks or charcoal.
- Bones that appear to be human or animal bones associated with a shell midden.
- An area of charcoal or very dark stained soil with associated artifacts,
- Artifacts made of chipped or ground stone (e.g., an arrowhead, adze, or maul) or an accumulation (more than one) of cryptocrystalline stone flakes (lithic debitage), fire-cracked rock (FCR) from hearth ovens, and bent wood.

- Basketry, cedar garments, fish weir stakes, or items made of botanical materials.
- Clusters of tin cans or bottles, logging, or agricultural equipment (not in use) that appear to be older than 50 years.
- Buried railroad tracks, decking, or other industrial materials.

Not all cultural resource material encountered will be potentially eligible for listing on the NRHP. To be eligible for the NRHP cultural resources identified during construction must be 50 years of age or older, meet one or more of the four criteria listed below, and retain sufficient physical integrity to convey historical significance (36 CFR 60.4). A building, site, object, or structure may be considered for inclusion in the NRHP if it meets at least one of the following criteria:

- 1. The property is associated with events that have made a significant contribution to the broad patterns of our history.
- 2. The property is associated with the lives of persons significant in our past.
- 3. The property embodies the distinctive characteristics of a type, period, or method of construction, or that represent the work of a master, or that possess high artistic values, or that represent a significant and distinguishable entity whose components might lack individual distinction.
- 4. The property has yielded, or might be likely to yield, information important in prehistory or history.

The following sections describe those materials that do or do not require a halt in construction.

3.1 Items that are not likely to be potentially eligible for listing in the NRHP

Aside from light rail related materials, the following types of materials are presumed not significant, and would not require a halt in work or investigation by the Project Archaeologist:

- Isolated cans or bottles,
- Materials less than 50 years old, and
- Abandoned utilities.

3.2 Materials that are likely to be eligible for listing in the NRHP

Specific examples of precontact archaeological materials may include, but are not limited to:

- stone tools and flaking debris;
- river mussel shell or non-sawed bone fragments;
- charcoal concentrations and darkened earth;
- fire-modified rock or unaltered cached rock piles;
- suspected human remains (see Section 4 below on Inadvertent Discovery of Human Remains);
- wooden posts (house posts, food drying racks); and
- basketry or fiber objects (cedar twine ropes, woven mats, cedar twine fishing nets).

Historic-period archaeological materials may include, but are not limited to:

- low-fired and bisque ceramics with subdued colors, or blue/pink willow-like design; thickbodied pieces, indicating crockery;
- non-tempered glass, violet-colored glass, stopper-topped glass jars or bottles, press-capped (cork gasket liner) heavy-walled soda bottles (not twist-top, thin-walled), zinc and vitreous glass-lidded glass canning jars with colored body;
- miscellaneous fragments of metal (or plated) clothing closures (buttons, hooks and eyes, and suspender fittings, but not zippers); sawed animal bone, bakelite, celluloid, glass and shell buttons (but no nylon or polystyrene);
- enameled ironware;
- punch-opened and solder-sealed beverage cans, solder-sealed food tins, general lack of thin-walled aluminum and welded steel cans;
- rock-picker piles collected by farmers and agricultural equipment or implements;
- older automotive parts;
- knob-and-tube electrical insulators; and
- residential structural remains, such as historic building foundations or privies.

3.3 Types of deposits that may be encountered

Isolate: One distinct artifact or a few fragments of the same artifact that are too far away (typically more than 50 meters) from other cultural materials to be considered part of a "site." Generally, an isolate will not take long to document. Regardless of the nature of the isolated artifact find (e.g., historic versus precontact, with or without diagnostic markers), it is to be recorded on a Washington Archaeological Site Inventory form, its location mapped, and photographs taken.

Intact Artifact Deposit or Feature: Two or more distinct artifacts or one feature (e.g., precontact fire hearth, historic-period concrete foundation) within a 50-meter area. Intact deposits are considered an archaeological site and must be recorded on a Washington Archaeological Site Inventory form.

Disturbed Artifact Deposits: Artifacts identified in disturbed soils (such as historic fill) should be documented in monitoring notes and photographed. Depending on the volume of artifacts and the level of disturbance, the site may or may not need to be recorded on a Washington Archaeological Site Inventory form. Limited investigation around the artifacts may be necessary to determine if additional materials are present and whether the site boundaries extend beyond the initial find, following the protocol steps outlined in Section 2.

4. INADVERTENT DISCOVERY OF HUMAN REMAINS/ SUSPECTED HUMAN REMAINS

Human remains or suspected human remains (the Discovery) shall be treated with respect and dignity. After discovery they shall be covered with a tarp or cloth, not soil, and shall remain untouched until the procedures outlined below are followed. No photographs shall be taken except by the Project Archaeologist who may need to photograph the bone for identification purposes. This photograph shall not be distributed outside contacts listed below in Section 5.3.

No persons other than the proper law enforcement personnel (County, City, or Tribal [see Contacts below]), the appropriate county's Medical Examiner, and professional archaeologists shall be authorized to access the discovery location after the area is secured. Assumptions must not be made concerning the origin of the human remains, and public disclosure of the find shall be avoided.

- 1. In the event that human remains or suspected human remains are discovered work shall immediately stop work in the area of the Discovery and the Project Archaeologist shall secure the area 50 feet (15.2 meters) in all directions. All spoils from the location of the Discovery shall remain on site.
- 2. The Project Archaeologist, in coordination with the Archaeological Technician and Sound Transit's Cultural Resource Program Manager shall verify if the Discovery is human remains.
 - a. If the Discovery is not human remains work may proceed but may need to follow procedures for archaeological finds above.
- If the Discovery is verified as human remains, the Project Archaeologist in coordination with Sound Transit shall notify the appropriate county's Medical Examiner and appropriate law enforcement (County, City, or Tribal) in the "most expeditious manner possible" (RCW 27.44; RCW 86.50; RCW 68.60). Sound Transit shall then notify FTA and SHPO of the Discovery.
- 4. The Medical Examiner, with the assistance of law enforcement personnel, shall formally determine if the remains are human, whether the discovery site constitutes a crime scene, and shall notify SHPO and the State Physical Anthropologist. If the Medical Examiner determines the remains are forensic, work shall resume only after the site has been cleared by law enforcement.
- 5. If the remains are not forensic, the State Physical Anthropologist shall make a determination of whether the remains are Native American or Non-Native American and report that finding to the affected parties, in coordination with FTA.
- 6. SHPO shall handle consultation with the affected parties as to the future preservation, excavation, and disposition of the remains.
- 7. During Steps 1-6 no additional ground disturbing work, including archaeological inventory shall occur within 50 feet of the Find without FTA and SHPO's written authorization.

5. COMMUNICATION AND CONTACT INFORMATION

Communication for the project shall include notifying the consulting tribes, survey crew orientation, and continual communication between Sound Transit and the Project Archaeologist. Any inadvertent discovery assessments, regular progress reports, and cultural resource investigation results summaries shall be provided to FTA for review. FTA shall provide documents to SHPO and consulting parties unless FTA directs Sound Transit to provide the document(s).

5.1 Tribal Notification

FTA shall notify tribal representatives via email of an invitation to observe investigations and provide them with a project schedule. FTA shall also notify tribal representatives if there are any changes to the schedule that may affect cultural resource investigations. Sound Transit coordinate all tribal communication with FTA and shall include SHPO on all communications and notifications to the tribes.

5.2 On-Site Communication

Prior to the commencement of any cultural resource investigations, the Project Archaeologist shall provide a 10- to 20-minute tailgate orientation for all crew involved in the investigations. The purpose of the orientation will be to inform and familiarize personnel with the IDP protocols.

Ongoing communication will be vital throughout the cultural resource investigations. The Project Archaeologist shall maintain communication with the Field Supervisor (or designee) as appropriate by email and/or phone. During the investigations, the Field Supervisor shall provide regular updates regarding progress and schedule to assist the Project Archaeologist and Sound Transit's Cultural Resources Program Manager.







FIGURE J5.3-1 APE and Historic Survey Parcels Tacoma Dome Link Extension






FIGURE J5.3-2 APE and Historic Survey Parcels Tacoma Dome Link Extension







FIGURE J5.3-3 APE and Historic Survey Parcels Tacoma Dome Link Extension








FIGURE J5.3-4 APE and Historic Survey Parcels Tacoma Dome Link Extension


FIGURE J5.3-5 APE and Historic Survey Parcels Tacoma Dome Link Extension


FIGURE J5.3-6 APE and Historic Survey Parcels Tacoma Dome Link Extension







FIGURE J5.3-9 APE and Historic Survey Parcels Tacoma Dome Link Extension







FIGURE J5.4-1 Alternatives to be Evaluated in the Draft EIS Tacoma Dome Link Extension







FIGURE J5.4-2 General Lands Office Plats South Federal Way Segment Tacoma Dome Link Extension








FIGURE J5.4-7 1912 City of Tacoma Sanborn Maps Within and Surrounding the APE









FIGURE J5.4-11 1940 Aerial Imagery Within and Surrounding the APE Tacoma Dome Link Extension







FIGURE J5.4-12 1940 Aerial Imagery Within and Surrounding the APE Tacoma Dome Link Extension







FIGURE J5.4-13 1940 Aerial Imagery Within and Surrounding the APE Tacoma Dome Link Extension







FIGURE J5.4-14 1940 Aerial Imagery Within and Surrounding the APE Tacoma Dome Link Extension





FIGURE J5.4-15 1940 Aerial Imagery Within and Surrounding the APE Tacoma Dome Link Extension





FIGURE J5.4-16 1940 Aerial Imagery Within and Surrounding the APE Tacoma Dome Link Extension







FIGURE J5.4-17 1940 Aerial Imagery Within and Surrounding the APE Tacoma Dome Link Extension




FIGURE J5.4-18 APE and Proposed Geoarchaeological Bore Locations Tacoma Dome Link Extension







FIGURE J5.4-19 APE and Proposed Geoarchaeological Bore Locations Tacoma Dome Link Extension





FIGURE J5.4-20 APE and Proposed Geoarchaeological Bore Locations Tacoma Dome Link Extension





FIGURE J5.4-21 APE and Proposed Geoarchaeological Bore Locations Tacoma Dome Link Extension






FIGURE J5.4-23 APE and Proposed Geoarchaeological Bore Locations Tacoma Dome Link Extension






FIGURE J5.4-24 APE and Proposed Geoarchaeological Bore Locations Tacoma Dome Link Extension





FIGURE J5.4-26 1931 Aerial Imagery Within and Surrounding the APE *Tacoma Dome Link Extension*





FIGURE J5.4-27 1931 Aerial Imagery Within and Surrounding the APE *Tacoma Dome Link Extension*





FIGURE J5.4-28 1931 Aerial Imagery Within and Surrounding the APE *Tacoma Dome Link Extension*





FIGURE J5.4-29 1931 Aerial Imagery Within and Surrounding the APE *Tacoma Dome Link Extension*






FIGURE J5.4-30 1931 Aerial Imagery Within and Surrounding the APE *Tacoma Dome Link Extension*





FIGURE J5.4-33 1950 Aerial Imagery Within and Surrounding the APE *Tacoma Dome Link Extension*





FIGURE J5.4-34 1950 Aerial Imagery Within and Surrounding the APE *Tacoma Dome Link Extension*





FIGURE J5.4-35 1950 Aerial Imagery Within and Surrounding the APE *Tacoma Dome Link Extension*




FIGURE J5.4-36 1950 Aerial Imagery Within and Surrounding the APE *Tacoma Dome Link Extension*





FIGURE J5.4-37 1950 Aerial Imagery Within and Surrounding the APE Tacoma Dome Link Extension




FIGURE J5.4-38 1973 Aerial Imagery Within and Surrounding the APE *Tacoma Dome Link Extension*





FIGURE J5.4-39 1973 Aerial Imagery Within and Surrounding the APE *Tacoma Dome Link Extension*





FIGURE J5.4-40 1973 Aerial Imagery Within and Surrounding the APE *Tacoma Dome Link Extension*




FIGURE J5.4-41 1973 Aerial Imagery Within and Surrounding the APE *Tacoma Dome Link Extension*




FIGURE J5.4-43 1972 Aerial Imagery Within and Surrounding the APE Tacoma Dome Link Extension




FIGURE J5.4-44 1972 Aerial Imagery Within and Surrounding the APE Tacoma Dome Link Extension




FIGURE J5.4-45 1972 Aerial Imagery Within and Surrounding the APE Tacoma Dome Link Extension





FIGURE J5.4-46 1972 Aerial Imagery Within and Surrounding the APE Tacoma Dome Link Extension





FIGURE J5.4-47 1972 Aerial Imagery Within and Surrounding the APE Tacoma Dome Link Extension





FIGURE J5.4-48 1972 Aerial Imagery Within and Surrounding the APE Tacoma Dome Link Extension




FIGURE J5.4-49 1972 Aerial Imagery Within and Surrounding the APE Tacoma Dome Link Extension




FIGURE J5.4-50 1972 Aerial Imagery Within and Surrounding the APE Tacoma Dome Link Extension




FIGURE J5.4-51 1935 South Federal Way Aerial Imagery Within and Surrounding the APE Tacoma Dome Link Extension





FIGURE J5.4-52 1935 South Federal Way Aerial Imagery Within and Surrounding the APE Tacoma Dome Link Extension





FIGURE J5.4-53 1935 South Federal Way Aerial Imagery Within and Surrounding the APE Tacoma Dome Link Extension






FIGURE J5.4-54 1935 South Federal Way Aerial Imagery Within and Surrounding the APE Tacoma Dome Link Extension





FIGURE J5.4-56 1941 South Federal Way Aerial Imagery Within and Surrounding the APE Tacoma Dome Link Extension






FIGURE J5.4-57 1941 South Federal Way Aerial Imagery Within and Surrounding the APE *Tacoma Dome Link Extension*





FIGURE J5.4-59 1957 South Federal Way Aerial Imagery Within and Surrounding the APE Tacoma Dome Link Extension





FIGURE J5.4-60 1957 South Federal Way Aerial Imagery Within and Surrounding the APE Tacoma Dome Link Extension





FIGURE J5.4-61 1957 South Federal Way Aerial Imagery Within and Surrounding the APE Tacoma Dome Link Extension





FIGURE J5.4-62 1957 South Federal Way Aerial Imagery Within and Surrounding the APE Tacoma Dome Link Extension





FIGURE J5.4-63 1965 South Federal Way Aerial Imagery Within and Surrounding the APE Tacoma Dome Link Extension





FIGURE J5.4-64 1965 South Federal Way Aerial Imagery Within and Surrounding the APE Tacoma Dome Link Extension





FIGURE J5.4-65 1965 South Federal Way Aerial Imagery Within and Surrounding the APE Tacoma Dome Link Extension
