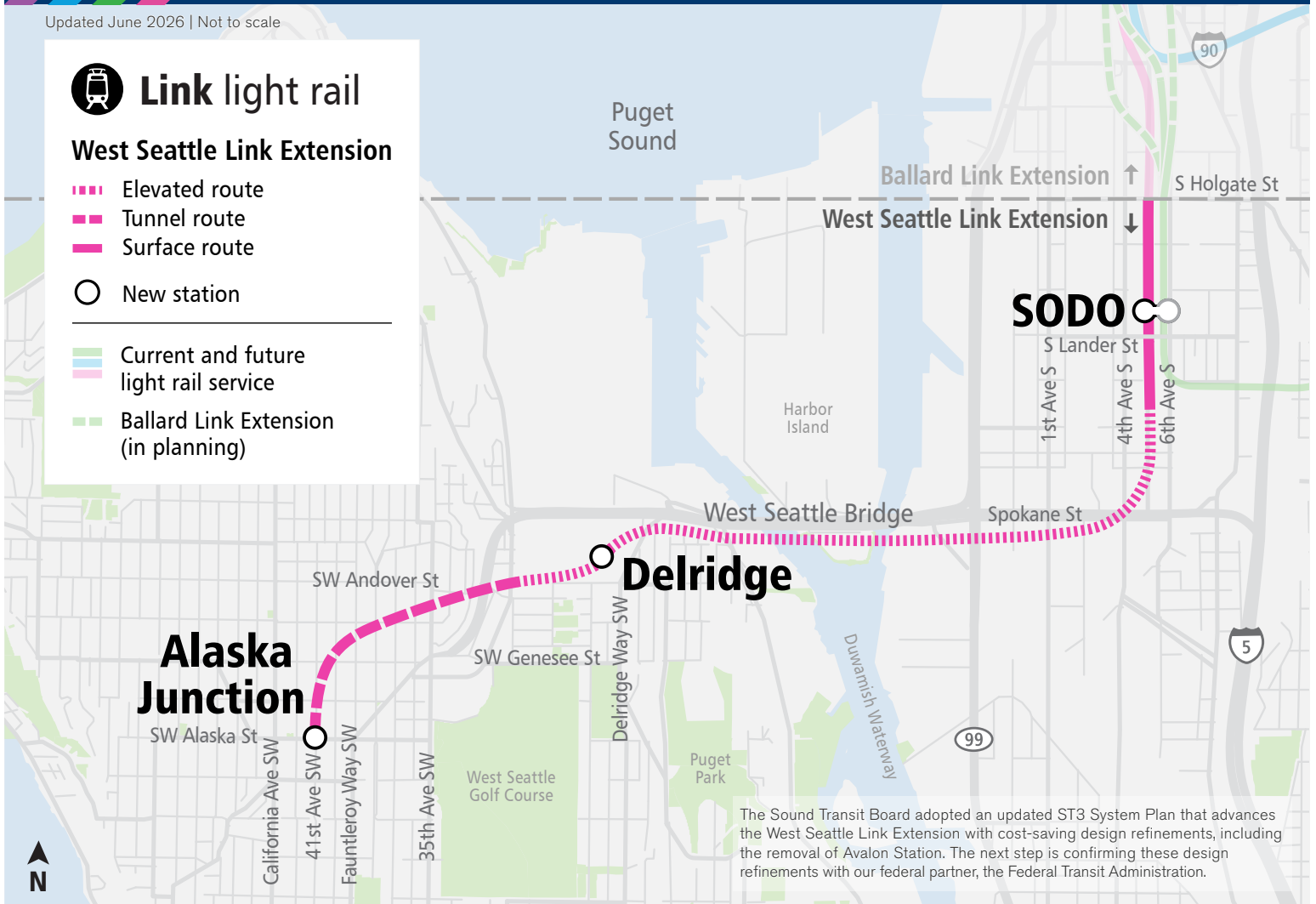

The West Seattle Link Extension (WSLE) will make it easier and faster to travel between West Seattle and the rest of the region. Whether you're commuting to work, heading to school, or exploring the city, Link light rail will connect you to key destinations in West Seattle, SODO, and beyond. The West Seattle Link Extension is part of Sound Transit 3, a voter-approved regional transit expansion.

Project benefits

- WSLE will serve more than 20,000 riders per day —providing a fast, frequent, and reliable way to get to and from West Seattle.
- WSLE will cut travel time in half from West Seattle to downtown (Westlake Station) once connected to the regional Link system.
- This project will enable the affordable housing and other developments around future stations.

What's next for West Seattle Link?

During final design, Sound Transit will:

- Continue to identify ways to reduce project cost and community impacts.
- Secure permits and plan for construction.
- Engage communities in final design, station naming, station art, and transit-oriented design visioning.
- Acquire the property we need to build the project and support businesses and residents through the relocation process.
- Begin early works, including preparing the site and relocating utilities for major construction.

How did we get here?

- **2016:** Voters approved Sound Transit 3.
- **2017:** Sound Transit began the project planning process.
- **Sept 2024:** Sound Transit published the WSLE Final Environmental Impact Statement (EIS).
- **April 2025:** Our federal partner, the Federal Transit Administration, issued a Record of Decision, completing the environmental review phase of the project.
- **May 2025:** WSLE began final design with a focus on refining design and identifying opportunities to reduce project costs and community impacts.
- **May 2026:** The Sound Transit Board adopted an updated ST3 System Plan that advances the West Seattle Link Extension with cost-saving design refinements, including the removal of Avalon Station. The next step is confirming these design refinements with our federal partner, the Federal Transit Administration.
