

Summer 2024: The 1 Line extends into Snohomish County with four new stations in Shoreline, Mountlake Terrace, and Lynnwood.





- 完成的新版BLE环境影响报告草案会包括新的首选方案和对备 选方案的改进。

Overview

- March 2023, the Sound Transit Board identified a Station North of CID (Midtown James Street Station) and a Station South of CID (CID Dearborn Street Station) as the preferred alternative for the Ballard Link Extension (BLE) in the Chinatown-International District.
- The Board also directed further study of the CID 4th Avenue Shallower Alternative as part of the environmental review process.
- A new BLE Draft EIS will be completed that includes the new Preferred Alternative and refinements to other alternatives.




- Builds on recent further studies effort and past community and agency planning efforts to continue engagement with the community.






