COMMUNICATIONS ANALYTICS

- Support for the Ballard station to be located on 15th Avenue NW or 17th Avenue NW
- Support for the Interbay station to be located at 17th Avenue W and W Dravus St to better serve pedestrians and transit connections
- Support for extensions that do not include movable bridges or at-grade crossings
- Support for station location options that serve large walksheds
- Support for alignments that include tunnels
- Support for mixing and matching elements from Level 3 alternatives
- Questions about impacts to property owners
- Questions about the West Seattle Extension design and construction schedule

BRIEFINGS (KEY FEEDBACK)

Questions and feedback received from briefings during the reporting period.

Corridor wide

- Support for frequent bus service to stations, so more people can access light rail
- Support for locating new stations near underserved communities and social service organizations
- Comment that safety concerns near light rail stations are a barrier to people using them
- Comment that community engagement needs to be a series of conversations to better understand the complex information associated with the project
- Question about what Sound Transit is doing to raise safety awareness around light rail stations
- Question about whether the new light rail extensions will reduce the quantity of buses on city streets

Interbay/Ballard (includes stations at Ballard, Interbay and Smith Cove)

· No feedback received.

Downtown (includes stations at Seattle Center, South Lake Union, Denny, Westlake and Midtown)

No feedback received.

SODO/Chinatown-International District (includes stations at Chinatown-International District, Stadium and SODO)

- Comment that outreach activities in Chinatown-International District need to engage students and employees, not just elders
- Comment about improving the pedestrian experience around S Lander Street
- Question about the different traffic and parking impacts associated with light rail alternatives on 4th and 5th avenues
- Question about impacts to the E-3 busway with the SODO alignments
- Concern about impacts to SODO businesses if light rail crosses the Duwamish waterway on the northside of the West Seattle Bridge

BRIEFINGS (KEY FEEDBACK)

Questions and feedback received from briefings during the reporting period.

West Seattle (includes stations at Delridge, Avalon and Alaska Junction)

- Question about how the West Seattle stations will serve White Center and other neighborhoods south of Delridge
- Question about whether the West Seattle alternatives could include a stop on Harbor Island
- Question about the proximity of the new light rail bridge to the existing West Seattle Bridge
- Question about the cost differences associated with the location of the proposed bridge across the Duwamish
- Comment about noise sensitivity in the Pigeon Point neighborhood

FESTIVALS

During the reporting period, the project team attended 2 tabling events to share information with the community, answer questions and discuss opportunities to stay engaged.

Real Change Vendor Meeting (Dec. 12, 2018)

- 20 community members stopped by the table
- Common questions and topics included wayfinding and station amenities
 - "Support for more security officers at light rail stations."
 - "Can there be more places to sit, public art and other amenities at stations?"
 - "More maps and signage at stations would help me get around better."

Greater Seattle Business Association Annual Meeting & Holiday Luncheon (Dec. 12, 2018)

- 55 community members stopped by the table
- Common questions and topics included station locations and service impacts
 - "How will the new downtown transit tunnel impact existing light rail service?"
 - o "Where will the Delridge station be located?"
 - "I'm so excited for the West Seattle and Ballard Link extensions!"
