Scoping and the Environmental Impact Statement (EIS)

Sound Transit and the Federal Transit Administration (FTA) are beginning the environmental analysis for the North Corridor Transit Project. This project is part of the Sound Transit 2 Plan approved by voters in 2008 to extend transit from Northgate to Lynnwood.

What is scoping, and what is an Environmental Impact Statement (EIS)?

- "Scoping" provides an opportunity for the public and agencies to learn about and provide comments on the project as environmental review begins.
- Scoping is a required step for an EIS prepared under the National Environmental Policy Act (NEPA) and the Washington State Environmental Policy Act (SEPA). An EIS analyzes and presents results of potential environmental effects of alternatives.

Potential alternatives for study

The Federal Transit Administration (FTA) is a potential funding partner for this project. To help qualify for federal funds, Sound Transit has completed an Alternatives Analysis that studied mode and corridor concepts. Sound Transit received valuable public feedback on potential corridors and station locations in October 2010 ("early scoping").

Key findings from Alternatives Analysis*:

- Light rail is the only transit mode that satisfies the North Corridor Transit Project's purpose and need.
- Light rail must operate in an exclusive right-of-way with full separation from traffic to provide the capacity, reliability, and travel time savings needed to address the corridor's growing demand for mass transit.
- In-street light rail is not recommended because it would not provide the capacity, reliability, and travel time savings needed in the corridor.

Potential I-5 light rail alternative

Light rail along the I-5 corridor offers the best overall performance across the broad set of evaluation criteria, including ridership, transportation performance, cost-effectiveness, and consistency with regional land use plans.

Potential SR 99 light rail alternative

While elevated light rail along SR 99 has the potential to meet the project's purpose and need, it does not perform as well as the I-5 alternative in most areas; it would have substantially higher project costs, property acquisitions, and community impacts during construction. It does appear to offer more transit-oriented development opportunities around stations than the I-5 alternative.

Next steps

After the public comment period ends, a report will summarize the comments and results of the scoping process. The report will be posted at **www.soundtransit.org/NCTP.** Sound Transit and FTA will use the comments received to help define the scope of the EIS.

- Late 2011 or early 2012: The Sound Transit Board of Directors is expected to identify alternatives to study in a draft EIS and may potentially identify a locally preferred alternative.
- Early 2012: Draft EIS development is expected to begin.
