

### **Sound Transit Discover. Stamp. Win! Official Rules**

Sound Transit is sponsoring the Discover. Stamp. Win! (DSW) activity. By completing and submitting the Crosslake Connection DSW stamp ticket entry form by visiting and getting stamps at the four stations along the new alignment (International District/Chinatown Station, Judkins Park Station, Mercer Island Station, South Bellevue Station), you can enter to win.
