Due to the COVID-19 pandemic and extension of shelter in-place orders, Sound Transit continued transitioning outreach with community groups, property owners and other stakeholders to virtual platforms during the reporting period. As a result of the global health crisis, many community briefings, meetings and events were postponed or cancelled. We are continuing to find creative ways to engage with the communities in which we work that support the recommendations to socially distance to enhance public safety.



Regional light rail expansion will help connect more people to more places.





## Emails and phone calls

During the reporting period, the project team received 12 comments and questions from emails and phone calls.

#### A few questions and comments

- Support for continued wildlife observations in West Seattle as part of the Environmental Impact Statement (EIS) process.
- Questions about alignments and potential station locations in Downtown and South Lake Union.
- Question about the Draft EIS timeline and the cost of the Ballard extension.
- Questions about fieldwork locations and temporary effects in SODO.
- Question about how Duwamish Valley organizations can get more involved in project conversations.
- Interest in aligning the design and construction of the West Seattle Link Extension with the
  design and construction of a new West Seattle High Bridge and questions about how that
  could occur. (Note: The City of Seattle announced a long-term closure of the West Seattle
  High Bridge on March 23, 2020.)
- Interest in more information about the Yancy/Andover alternative in West Seattle.



## Introductory calls and emails

During the reporting period, the project team reached out to 98 stakeholders to inform them about the project and answer questions. This outreach primarily focused on property managers of multi-family residential buildings and hotels located near potential station options. Of the 98, the project team connected directly with 55 stakeholders through phone, email or a virtual briefing.
