It will help Sound Transit, our partner agencies, the public and other decision makers understand the potential impacts and benefits of each alternative by describing how they might affect the natural and built environments and transportation systems during both construction and future operation. We expect to publish the West Seattle and Ballard Link Extensions Draft EIS for public review and comment in fall 2021.




