

Summary Minutes

CEO Selection Committee Meeting April 8, 2022

Call to order

The meeting was called to order at 11:02 a.m. by Committee Chair Keel virtually on WebEx.

Katie Flores, Board Administrator, announced that a quorum of the CEO Selection Committee was present at roll call. Boardmember Claudia Balducci was in attendance as a non-voting member.

Report of the Chair

Chair Keel welcomed the consultants from Cooperative Personnel Services, known as CPS HR Consulting.

Public comment

Chair Keel announced that public comment would be accepted via email to emailtheboard@soundtransit.org and would also be accepted verbally.

There was no verbal public comment.

Recruitment timeline and workplan

CSP HR consultants Andrew Nelson and Joanne Peterson provided the report. Ms. Peterson reviewed the work done to date. The consultants met with more than 50 stakeholders and presented findings at the January meeting and three additional public comment sessions. An online survey was also run. She reviewed the findings from that outreach work.

Mr. Nelson reviewed the ideal candidate profile, which was a culmination of the outreach feedback. The position was open for around one month, nearly 90 submissions were received, and 48 candidates met the minimum requirements. The consulting team screened these candidates for the "ideal candidate" qualifications. Seventeen candidates met that profile with three removing their applications, leaving 14 candidates. The consultants conducted screening interviews with all which included a leadership quiz, a

video introduction, and behavioral-based interview questions. Following those interviews, the consulting team was recommending nine candidates to advance.

Mr. Nelson reviewed screening questions used in the screening process gathered from its outreach with the public and stakeholders.

Ms. Peterson reviewed the candidate demographics. Thirty-seven percent of the total pool identified as a diversity candidate. Fifty-two percent of the candidates who met the minimum qualifications identified as a diversity candidate, and forty-six percent of the ideal candidates identified as a diversity candidate.

The committee would discuss the candidate screening in its executive session, followed by committee interviews later in April.
