- A. **Resolution No. R2026-20:** Amending the Adopted 2026 Budget to create the Renton Transit Center Garage project by (a) establishing an Authorized Project Allocation through the completion of the Conceptual Engineering/Design Validation Phase in the amount of \$10,000,000 and (b) establishing a 2026 Annual Project Budget of \$1,425,000. – *Recommended by the System Expansion Committee; requires a supermajority vote*
