Proposed action

Authorizes the Chief Executive Officer to execute contract modifications with David Evans and Associates Inc. for Phase 1 Alternatives Analysis for the Lakewood Station Access Improvements project and the South Tacoma Access Improvements project in an amount of \$1,448,853 with a 10 percent contingency of \$144,885 totaling \$1,593,738, for a new total authorized contract amount not to exceed \$3,312,627, contingent upon Board approval of Resolution No. R2020-19 and Resolution No. R2020-20.

Key features summary

- The purpose of the contract amendment is to have David Evans and Associates Inc. (DEA) support the work for the Lakewood and South Tacoma Access Improvements Projects Phase 1 – Alternatives Analysis.
- The scope of work for Phase 1 Alternatives Analysis is estimated to take 9 months for both projects and divided in to five tasks: Administration, Baseline Study, Stakeholder Involvement, Alternatives Development, Alternatives Refinement.
- At the end of the Alternatives Analysis phase for both projects, the Sound Transit Board of Directors will be asked to authorize the next phase of the project, conceptual engineering and environmental review, for preferred station access improvements, pending capital program realignment decisions.
- There are two related actions, Resolution R2020-19 and Resolution R2020-20, which would increase authorized project allocation for the Lakewood Station Access Improvements and South Tacoma Station Access Improvements projects respectively.
- There is an option for DEA Inc. to do both Phase 2 Conceptual Engineering and Environmental Assessment, and Phase 3 Preliminary Engineering of both projects. Staff would return to seek approval to execute future options.


Background

In November 2008, voters approved the ST2 Plan, which included the Lakewood and South Tacoma Access Improvements Projects. In 2019, the Sounder South program conducted a strategic development and implementation plan process for the Sounder South corridor. The Lakewood and South Tacoma Access Improvements Projects were identified as projects to initiate in 2020. The purpose of these projects are to identify access improvements for the Lakewood and South Tacoma Sounder stations.

This action seeks to execute two options in the Preliminary Engineering Consultant Contract with DEA to support the work in Phase 1 - Alternatives Analysis for both projects. During this phase, DEA will assist Sound Transit in identifying station access improvement options that will be packaged into alternatives for project evaluation. The results of the alternatives evaluation for the station will be presented to the Sound Transit Board, who will be asked to identify a preferred alternative for the station access improvements. The Alternatives Analysis phase of the project is estimated to take 9 months and this scope of work and budget covers all the work required of DEA in this Phase.

As of this writing, the Sound Transit Board is undertaking a realignment process in response to the financial effects of COVID-19, which may affect the products and timing of Alternatives Development and/or subsequent project phases.

Procurement information

This Sounder Planning & Preliminary Engineering consultant contract for engineering services was procured in accordance with requirements for Architecture/Engineering procurements. Sound Transit evaluated all proposals submitted in accordance with the evaluation criteria included in the solicitation. Price was not a factor. David Evans and Associates, Inc. was determined to be the most qualified firm, and after negotiations, Sound Transit entered into Contract RTA/AE 0145-17 with David Evans and Associates, Inc. on November 30, 2018. The contract contains options for each phase of each project that is within the scope. Both projects that are subject of this action are within the anticipated scope of work of the Contract. The Contract Specialist, in conjunction with project team and independent estimators, has determined that the not to exceed price of Phase 1-Alternatives Analysis for each project is fair and reasonable.

Fiscal information

This action is within the authorized project allocation contingent upon approval of Resolution R2020-19 and Resolution R2020-20 and sufficient monies remain after approval of this action to fund the remaining work in the preliminary engineering phase.

The action with David Evans and Associates Inc. (DEA) for \$1,593,738 will provide for Phase 1 Alternatives Analysis that encompasses two Sounder projects as follows:

- Lakewood Station Access Improvements for an amount not to exceed \$787,532 (\$715,939 plus \$71,594 contingency); and
- South Tacoma Station Access Improvements for an amount not to exceed \$806,205 (\$732,913 plus \$73,291 contingency);

Lakewood Station Access Improvements

The authorized project allocation for the Lakewood Station Access Improvements project is \$1,960,000. Within the amount, \$1,018,549 has been allocated to preliminary engineering phase for Phase 1

Alternatives Analysis. The action would commit \$787,532 to this line item and leave a budget balance of \$231,017.

South Tacoma Station Access Improvements

The authorized project allocation for the South Tacoma Station Access Improvements project is \$1,534,000. Within the amount, \$1,019,000 has been allocated to preliminary engineering phase for

phase 1 Alternatives Analysis. The action would commit \$806,205 to this line item and leave a budget balance of \$212,795.
