#### On-Call Contract for Ridership Forecasting Support Services

#### **Proposed action**

Authorizes the chief executive officer to execute a three-year contract with two one-year options to extend with WSP USA Inc. to provide ridership forecasting support services in the amount of \$3,436,160, for a total authorized contract amount not to exceed \$3,436,160.

#### Key features summary

- Under this contract, WSP USA Inc., will provide the ridership forecasting services needed for a wide variety of planning efforts.
- The contract includes services to:
  - assess ridership forecasting recommendations submitted by a group of industry expert panelists during a peer review conducted in 2021;
  - o implement the peer review panel recommendations as determined by the assessment; and
  - o update, maintain, apply, and document Sound Transit's ridership forecasting model as needed.
- The requested contract amount includes the base three-year term and the two one-year options.

## Background

Sound Transit uses an incremental data-driven ridership forecasting model. The model is used in support of ongoing planning and development efforts including operations and capacity planning, project development, environmental studies, and financial planning. The model is also used to help describe system and project ridership benefits and other related information for grant applications, and for communications to the public and other stakeholders. This contract provides the ridership forecasting services necessary to apply the model for these various planning and development efforts.

In cooperation with the American Public Transportation Association (APTA), Sound Transit convened an expert panel in 2021 to review our ridership forecasting methods and procedures. As a result of the review, the panelists developed a series of recommendations to improve our ridership forecasting methods. However, the panelists also acknowledged they did not fully assess the implications of these recommendations. So, the panel called on Sound Transit to assess the recommendations, and this contract includes the scope of work to conduct this assessment. It also includes the capacity to implement the recommendations as determined by the assessment.

Transit ridership patterns will continue to evolve in the current environment of a rapidly growing light rail system and COVID pandemic recovery. This contract provides the services needed to monitor these evolving trends and patterns and maintain and update the model as necessary. It also allows for the use of other forecasting tools that could be deemed better suited for specific planning purposes.

#### **Procurement information**

A Request for Proposal (RFP) for Ridership Forecasting Support Services was advertised on January 10, 2022. Two proposers submitted proposals on February 10, 2022.

After proposals were received, Sound Transit's evaluation team evaluated the proposals in accordance with the evaluation criteria published within the RFP resulting in WSP USA Inc. having the highest rated proposal.

Sound Transit recommends award of this contract based upon the determination that WSP USA Inc.'s proposal best meets the evaluation criteria, fulfills the scope of work, and offers the best value for the Agency.

### **Fiscal information**

ST3 Planning

This action is within the authorized project allocation and sufficient monies remain after approval of this action to fund the remaining work in the operations & maintenance phase.

The authorized project allocation for the ST3 Planning project is \$41,525,000. Within that amount, \$41,524,638 has been allocated to the operations & maintenance phase. The action would commit an additional \$3,436,160 leaving and uncommitted balance in the operations and maintenance phase of \$3,678,602.
