Contract Modification with Cambridge Systematics for Open Transit Data

Proposed action

Authorizes the chief executive officer to execute a contract modification with Cambridge Systematics to fund the contract in the amount of \$1,000,000 for a new total authorized aggregate contract amount not to exceed \$3,500,000.

Key features summary

- This action seeks authorization for additional funding of \$1,000,000 to the current contract amount of \$2,500,000 to fund the existing contract term to 2023 and funding the five one-year extensions expiring in August 2028 established in the original contract.
- This contract modification would enable Sound Transit to sustain the progress and continuation of the contract performance to ensure the quality and timely deliverables of the One Bus Away (OBA) application services and Open Transit Data (OTD) services that serves Real time Transit Data.
- This action would support to sustain the current OBA/OTD systems development that would enable OBA/ Passenger Information Management System (PIMS) to continue to serve our riders and Sound Transit Passenger Experience Team, and to enable and sustain digital toolset and service schedules.
- Based on current internal planning, Sound Transit does not foresee the need to extend this contract beyond this contract modification.

Background

In July 2016, the Board authorized Motion No. M2016-65, to execute a five-year term with ten one-year options with Cambridge Systematics for the provision of Open Transit Data (OTD), which is a Software-as-a-Solution hosting application that is in production and will be integrated with Sound Transit's Passenger Information Management System (PIMS) platform in Q4 2022.

Cambridge Systematics was Sound Transit's vendor for the first phase of the OTD program. Cambridge built the original system, streamlined the data import and validation process, and worked with Sound Transit Staff to troubleshoot issues with data quality and availability.

Procurement information

This contract was the result of a competitive Request for Proposals process in 2016, where Cambridge Systematics, Inc. was selected as the top ranked consulting firm for the scope of work and services envisioned. This proposed modification is within the contract's not-to-exceed amount authorized under

the contract. The original contract amount was considered to have been fair and reasonable considering the level of effort required under the respective tasks in the SOW as described in the contract.

Sound Transit exercised its option to extend via Modification of Contract No. 002 to RTA/RP 0015-16 to August 14, 2023, on date March 22, 2022.

Fiscal information

This action entails a contract modification with Cambridge Systematics for an additional \$1,000,000 to purchase services. The contract modification includes funding from both the Passenger Information Management Systems program and the Information Technology (IT) department for a total authorized amount not to exceed \$3,500,000.

The Digital Passenger Information System program budget is \$49,575,848. Within that amount, \$39,804,129.80 has been allocated to the construction phase. The action would commit an additional \$100,000 and leave a phase uncommitted budget balance of \$3,407,438.

The remaining balance of \$900,000 for this action, will be funded from the services category within the IT department's annual operating budget(s). The services category budget is \$12,008,927 of which a total of \$100,000 is estimated to be spent in 2022. The balance of the action \$800,000 will be included in future annual department budget development processes.

This action does not have an impact on the affordability of the Agency's Finance Plan.
