Proposed action

Authorizes the chief executive officer to execute a contract with Harborland2c LLC to provide construction services for the Central Operations Maintenance Facility Light Rail Vehicle Pit Platform Gates in the amount of \$93,976 with a 25 percent contingency of \$23,494 for a total authorized contract amount not to exceed \$117,470, plus applicable taxes.

Key features summary

- The bid price for the work of this contract is 43 percent higher than the Sound Transit Independent Cost Estimate (ICE). Sound Transit committee approval is required when the bid price is 20 percent or more than the Independent Cost Estimate per Resolution No. R2018-40, the Board's Procurement, Agreements and Delegated Authority Policy.
- This project will consist of adding guardrails and swing gates to existing rail vehicle access platforms at Central Operations and Maintenance Facility (OMF).
- As a result of a Public Works Small Works Roster bid, three bids were received with the lowest of the three being 43 percent higher than the ICE amount of \$65,560 (including contingency). The bids included higher prices due in part to market conditions resulting from labor shortages and material availability and price. The ICE was prepared estimating at a lower labor rate due to the nature and size of the project and material cost for the work.
- Applicable taxes for this contract are estimated at \$9,633.

Background

During the most recent safety inspection of the Sound Transit Operations and Maintenance Facility (OMF), it was observed that providing steel guardrail systems with swing gates at 32 Light Rail Vehicle (LRV) access platforms was necessary. A fall hazard was present when the maintenance bays were unoccupied with an LRV. The presence of a parked LRV mitigates the risk at the maintenance bays. Each Operations and Maintenance facility gets inspected individually by the Sound Transit safety team. Other OMF locations are equipped with safety measures including gates, chains, and railing.

Procurement information

Bids for this project were solicited under the Small Works Roster. An Independent Cost Estimate (ICE) was produced in the amount of \$59,600.00 and identified an additional 10 percent contingency that would total \$65,560.00. The subject contract award for Central OMF LRV Pit Platform Gates is the result of an

Invitation for Bid sent on October 14, 2022 to the 133 approved contractors listed on Municipal Research and Services Center (MRSC) Small Works Roster, using description that fits the services required from the lists provided. Three bids were received by Sound Transit on December 9, 2022.

The apparent responsive, responsible low bidder is Harborland2c LLC with a price of \$93,975.96, which is 43 percent higher than the ICE of \$65,560.00. Independent cost estimate analysis indicates that the estimate did not include current market conditions for materials (availability and price increases) such as labor shortages and material availability.

Sound Transit Procurement staff determined that the bid amount is fair and reasonable after conducting responsive and responsible bidder review, reviewing the ICE, discussions with estimators and Project Manager for the project, and confirming other bids as additional indicator of market conditions.

Fiscal information

This action is within the authorized project allocation and sufficient monies remain after approval of this action to fund the remaining work in the construction phase. This action does not have an impact on the affordability of the Agency's Finance Plan.

The authorized project allocation for the Link OMF Pit Fall Protection project is \$535,000. Within that amount, \$400,000 had been allocated to the construction phase for Link OMF Pit Fall Protection. The action would commit an additional \$127,103 (including estimated taxes and contingency) to the contract in the construction phase and leave a project budget balance of \$150,691.
