Proposed action

Reappointing Lorenzo Frazier, Charlotte Murry, Tom Norcott, and Tina Pierce to the Community Oversight Panel to serve a second three-year term beginning September 1, 2025, and expiring August 31, 2028.

Key features summary

- This action would appoint Lorenzo Frazier, Charlotte Murry, Tom Norcott, and Tina Pierce to serve a second three-year term on the Community Oversight Panel.
- Each of the members were appointed in 2022 to serve the first of three available three-year terms. The members are approaching the end of that first term.
- Charlotte Murry and Tom Norcott represent Snohomish County. One position representing Snohomish County is vacant and a recruitment effort is underway to find a candidate to fill the vacancy.
- Tina Pierce represents North King County. One position representing North King County will be vacant and a recruitment effort is underway to find a candidate to fill the vacancy.
- Lorenzo Frazier represents South King County. One position representing South King County will be vacant and a recruitment effort is underway to find a candidate to fill the vacancy.

Background

The Sound Transit Community Oversight Panel (COP) is a 15-member advisory committee of community volunteers appointed by the Sound Transit Board to monitor and report on Sound Transit's performance in delivering on the commitments it made in Sound Move, ST2, and ST3. The COP is charged with an annual review of Sound Transit's performance and financial plan and provides reports and recommendations to the Board.

The current responsibilities include monitoring Sound Transit's performance in the following areas:

- Community engagement activities
- Project planning and alignment decisions
- Budget and financial plan
- Project schedule and budget adherence

- · Agency performance audits
- Social justice and equity
- Passenger experience

- Having experience, skills, or insight in one or more of the Community Oversight Panel's

 and financial plan, project schedule and budget adherence, agency performance audits, social
 justice and equity, and passenger experience.
- Being able to attend meetings once each month in the evening, either in person or via virtual meeting platform.
