### Amend ST Express Agreement with Pierce Transit for Operations and Maintenance Services

### Proposed action

Authorizes the chief executive officer to execute an amendment to extend the ST Express Service Operations and Maintenance Agreement with Pierce Transit for six months through June 30, 2021.

### Key features summary

- The current agreement with Pierce Transit expires on December 31, 2020. Staff from both agencies are currently actively negotiating a new agreement; however, more time is needed to address the following issues:
  - Understanding near and long-term ridership impacts of the COVID-19 crisis.
  - Developing long term service plans that respond to changing ridership demand, capital expansion realignment and fiscal constraints.
- Both parties have agreed that this six month extension is necessary to finalize a more informed agreement.
- Pierce Transit is expected to approve of the extension in their August 10, 2020 meeting.

### Background

Sound Transit and Pierce Transit entered into a Service Operations and Maintenance Agreement on July 6, 2015. The agreement term was extended to December 31, 2019 after two one-year options were exercised. The agreement was extended by an additional year to December 31, 2020 through Motion No. M2019-85 which was approved by the Sound Transit Board on July 25, 2019.

Both parties are currently engaged in productive negotiations. However, due to demands on staff time to address COVID-19 issues and the need for a better understanding of how those issues will affect future near and long-term ST Express services, both parties have agreed that additional time would be beneficial in arriving at a more informed agreement.

## **Fiscal information**

Funding for 2020 for this agreement is included in the Purchased Transportation category within the Operations department's annual operating budget. The Purchased Transportation category budget is \$203,425,480, of which \$55,829,490 is budgeted for Pierce Transit.

Funding for 2021 for this agreement will be included in the annual budget development process based on negotiated estimated costs as provided by Pierce Transit in conformance with the proposed agreement and the service assumptions provided in the Service Implementation Plan for that year.

## **Prior Board/Committee actions**

Motion No. M2019-85: Authorized the chief executive officer to execute an amendment to extend the ST Express Service Operations and Maintenance Agreement between Pierce Transit and Sound Transit for one year through December 31, 2020

Motion No. M2018-138: Authorized the chief executive officer to execute an amendment to an agreement between Pierce Transit and Sound Transit for ST Express Bus Service Operations and Maintenance. The amendment modified a cap on administrative expenses that could be charged to the agreement.

Motion No. M2015-055: Authorized the chief executive officer to execute an agreement with Pierce Transit to provide ST Express bus operations and maintenance services for the period of July 1, 2015 through December 31, 2017, with two additional one-year options to extend.

A motion of the Board of the Central Puget Sound Regional Transit Authority authorizing the chief executive officer to execute an amendment to extend the ST Express Service Operations and Maintenance Agreement with Pierce Transit for six months through June 30, 2021.

### Background

Sound Transit and Pierce Transit entered into a Service Operations and Maintenance Agreement on July 6, 2015.
