Proposed action

Authorizes the chief executive officer to execute an extension to the existing Law Enforcement Services Agreement with the City of Lynnwood for two additional years, in an amount not to exceed \$710,818, to maintain continuity of services while Sound Transit continues development of a comprehensive regional safety, security and law enforcement framework.

Key features summary

- This action authorizes a two-year extension of the expiring agreement with the City of Lynnwood to continue enhanced law enforcement services at Lynnwood City Center Station and surrounding Sound Transit facilities.
- Sound Transit has coordinated with Lynnwood Police, and both parties intend to exercise the options and continue performance – pending Board approval – in support of safety and security operations on Sound Transit property.
- The extension provides necessary time for Sound Transit to continue front-line safety modernization efforts, regional coordination, and engagement with law enforcement agencies across Snohomish, King, and Pierce Counties.
- This extension ensures service continuity while Sound Transit evaluates long-term regional approaches to safety, security, and law enforcement services.
- Funding for the extension period will be requested through future budget actions and remains consistent with the agency's operating plan assumptions.

Background

Since 2008, Sound Transit has relied on a combination of contracted and jurisdictional law enforcement services to support safety across the system.

With the expansion of Link light rail into Snohomish County, including Lynnwood City Center Station, Sound Transit has experienced increased demand for coordinated law enforcement presence similar to other system termini.

In 2025, Sound Transit executed a one-year agreement with the City of Lynnwood for supplemental law enforcement services, with both parties intending to exercise the available extension options. Although this arrangement was designed as an interim solution while the agency developed a comprehensive, systemwide approach to security and law enforcement coverage, additional time is required to complete this assessment and implement a long-term strategy.

Since execution of the original agreement, Sound Transit has expanded front-line safety capabilities through Security Operations Center (SOC) and Field Activity Specialist Team (FAST) internalization efforts, strengthened regional public safety coordination, and successfully supported major system expansions and FIFA World Cup operations. These efforts have strengthened the agency's ability to provide a safe and secure environment for passengers while informing evaluation of long-term regional safety and law enforcement approaches.

The agreement with the City of Lynnwood has successfully provided dedicated law enforcement support at Lynnwood City Center Station, supporting incident response, visible patrols, and enhanced coordination with Sound Transit frontline safety resources. From December 2025 through May 2026, officers responded to 1,556 incidents, with arrests occurring in 196 incidents (13%) and case reports generated in 245 incidents (16%).

Evaluation of a long-term regional safety and law enforcement model is underway but not yet complete, including:

- Evaluation of jurisdictional roles and responsibilities
- Engagement with partner law enforcement agencies
- Assessment of resource needs and funding approaches

The complexity of this effort reflects the need to align multiple law enforcement agencies across a three-county service area, each operating under distinct governance structures, policies, and operational practices. Advancing a regional approach requires sustained collaboration among partner jurisdictions, development of clear coordination and response protocols, and thorough evaluation of all available options—including maintaining the current service model, enhancing existing arrangements, and pursuing alternative regional frameworks. This work also involves assessing service delivery, funding, and governance considerations to ensure any future approach is operationally effective, fiscally responsible, and capable of providing consistent, equitable, and reliable public safety services across the region.

A two-year extension will allow Sound Transit to responsibly navigate these complexities and develop a coordinated, sustainable regional approach.

Fiscal information

This action will amend the current agreement by \$710,818, including estimated applicable taxes, for a new total authorized agreement amount not to exceed \$1,066,227, including estimated applicable taxes. This action will be funded from the Transit Operations department's annual operating budget. Within the services category, the security & safety budget is 86,965,749, of which \$213,387, including estimated applicable taxes, is estimated to be spent from this contract in the remainder of 2026 and is currently within the agency's budget authority.

After approval of this action, sufficient budget remains to cover remaining annual expenditures. Funding for the additional years of the agreement will be included in future annual budget requests.

This action does not impact the affordability of the agency's Financial Plan, as the services are already incorporated in the annual operating plan.

Pending execution of the agreement, Lynnwood has agreed to provide limited short-term support. A one-month delay could result in a gap in supplemental law enforcement services at Lynnwood City Center Station and reduce continuity of service.
