Summary of Changes to the Agency Safety Plan

- Collaborated with staff and external partners to ensure continued compliance with updated 49 CFR 673, Public Transit Agency Safety Plan.
- Updated safety performance targets for 2025.
 - 5% improvement based on previous 3-year performance.
