On any further interactions without proof of payment in a 12-month period, the agency may issue a \$100 fine, which must also include non-monetary options for a passenger to dispute or resolve the fine. \$124 civil infraction. A passenger may continue to ride the system after receiving a warning or, fine or notice of civil infraction.	
	2.4.4 Sound Transit refers civil infractions to district court for resolution.	
	2.5 <b>Delegation of authority.</b> The CEO is authorized to establish appropriate methods for demonstrating proof of payment and must regularly publish a list of valid fare media. The CEO may designate fare compliance personnel to ensure compliance with this policy and must develop procedures and appropriate training to implement this policy and take all other action as may be necessary to provide for fare compliance and issuance and resolution of warnings, and fines and civil infractions, including establishing alternative resolution and dispute processes. Notices of fines and civil infractions must be issued on forms approved by legal counsel. The CEO takes actions to continually measure, analyze and improve fare compliance processes and must report to the Board or appropriate Board committee at least quarterly regarding implementation of this policy.
