### Proposed action

Amends the Lakewood Station Access Improvements project budget for the administration, preliminary engineering, and right of way activities to support the completion of alternatives analysis by increasing the authorized project allocation by \$705,000 from \$1,255,000 to \$1,960,000.

### Key features summary

- The goal of the project is to provide access improvements to the Lakewood Sounder Station from the surrounding community to accommodate future demand for ridership.
- The scope of the project will focus on making improvements to non-motorized and transit transportation modes. Parking improvements at the existing parking lot are under consideration but a new parking structure is not envisioned to be part of the access improvements. The cost of structured parking is not affordable within the ST2 plan estimate and the amount included in Sound Transit's Transit Improvement Plan.
- Phase 1 – Alternatives Analysis Phase is estimated to take 9 months and is divided into five tasks: Administration, Baseline Study, Stakeholder Involvement, Alternatives Development, and Alternatives Refinement.
- At the end of Phase 1 – Alternatives Analysis, the Sound Transit Board of Directors will be asked to authorize the next phase of the project, conceptual engineering and environmental review, for preferred station access improvements, pending capital program realignment decisions.

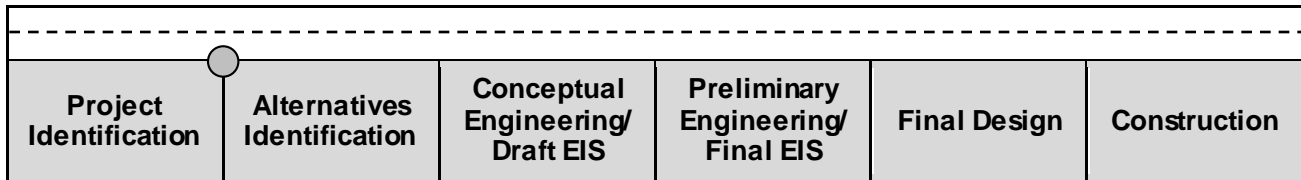
### Background

The Lakewood Access Improvements Project was part of the voter approved ST2 initiative. In 2019, the Sounder South program conducted a strategic development and implementation process for the Sounder South corridor. The Lakewood Access Improvements Project was identified as a project to initiate in 2020.

The Lakewood Access Improvements Project was originally to begin the the alternative analysis phase in Spring 2020. Due to the COVID-19 pandemic, this project action was put on pause. At the September 2020 Board meeting, the Board identified and approved which project actions should be considered to advance. The Lakewood Access Improvements Projects was included in that Board decision (M2020-55). With the approval of this action, the project team will begin the alternative analysis phase.

- The goal of the project is to provide access improvements to the Lakewood Sounder Station from the surrounding community to accommodate future demand for ridership. The scope of the project will focus on making improvements to non-motorized and transit transportation modes. Parking improvements at the existing parking lot are also under consideration; however a new parking structure is not envisioned to be part of the access improvements. The cost of structured parking is not affordable within the ST2 plan estimate and the amount included in Sound Transit's Transit Improvement Plan.
- Strategies for achieving these improvements could include:
  - Pedestrian improvements within one-quarter mile of the Lakewood Station,
  - Additional bus/transfer facilities at Lakewood Station,
  - Bicycle improvements within one-half mile,
  - Transit speed and reliability improvements on routes connecting the facility,
  - Expanded or new kiss-&-ride areas at Lakewood station

A RESOLUTION of the Board of the Central Puget Sound Regional Transit Authority amending the Lakewood Station Access Improvements project budget for the administration, preliminary engineering, and right of way activities to support the completion of alternatives analysis by increasing the authorized project allocation by \$705,000 from \$1,255,000 to \$1,960,000.

WHEREAS, the Central Puget Sound Regional Transit Authority, commonly known as Sound Transit, was formed under chapters 81.104 and 81.112 of the Revised Code of Washington (RCW) for the Pierce, King, and Snohomish Counties region by action of their respective county councils pursuant to RCW 81.112.030; and

WHEREAS, Sound Transit is authorized to plan, construct, and permanently operate a high-capacity system of transportation infrastructure and services to meet regional public transportation needs in the Central Puget Sound region; and

WHEREAS, in general elections held within the Sound Transit district on November 5, 1996, November 4, 2008, and November 8, 2016, voters approved local funding to implement a regional high-capacity transportation system for the Central Puget Sound region; and

WHEREAS, ST2, the plan for expanding high-capacity transit in the Central Puget Sound includes funding for providing access improvements to non-motorized and transit transportation modes at Lakewood Sounder Station; and

WHEREAS, after the Alternatives Analysis Phase of the project is complete the Board will identify a package of preferred improvements to advance for further study.

NOW THEREFORE BE IT RESOLVED by the Board of the Central Puget Sound Regional Transit Authority that the Lakewood Station Access Improvements project budget for the administration, preliminary engineering, and right of way activities is amended to support the completion of alternatives analysis by increasing the authorized project allocation by \$705,000 from \$1,255,000 to \$1,960,000.
