## **ACTION:**

Adopt Motion No. M2000-28 reappointing seven members to the Citizen Oversight Panel whose terms expire March 2000.

# **BACKGROUND:**

When the Citizen Oversight Panel was formed, the original members' terms were staggered with half assigned two-year terms and half assigned three-year terms. The members can be reappointed another three-year term not to exceed six years. The original three-year terms will expire March 2000. Each member with an expiring term has indicated they would like to be reappointed to another three-year term expiring March 2003. The seven members requesting reappointment are: Art Carter, Allan Darr, Bertha Eades, Virginia Gunby, Tony Hudson, Larry Shannon, and Tom Luthy.
