# **OBJECTIVE OF ACTION**

• To provide independent staff support for the Citizen Oversight Panel (COP).

### **ACTION**

• Approve the fourth and final contract extension with Prospect Delta in the amount of \$71,000 for a new total authorized contract amount not to exceed \$271,000, expiring on 12/31/02.

One of the commitments in Sound Move was the creation of the COP to provide on-going oversight of the activities of the Sound Transit Board and staff, and to regularly report to the public about whether Sound Transit was delivering on the promises made to the voters. The COP was first established in 1997 and needed independent staff assistance to support its activities. On behalf of COP, Sound Transit staff issued an RFP and received proposals from several firms. The COP interviewed those respondents and selected Prospect Delta as the preferred consultant.

Sound Transit negotiated a contract term of one year, expiring on 12/31/98 with four one-year extensions permitted, if the work met the expectations of COP. The initial contract amount was for \$50,000. Because this contract was included in the current year budget and was of small monetary value, the Board's procurement policies allowed for the contract to be signed without requiring Finance Committee approvals.

This initial contract has been extended three times, in one-year increments, with the current term ending 12/31/01. Each extension has also added approximately \$50,000 in budget, for a total four-year cost of \$200,000. Since the total contract amount has been less than \$200,000 and the cost of the contract has always been included in the Sound Transit budget, it has not required Finance Committee approval. Each contract extension has had the endorsement of the COP, who continue to be satisfied by Prospect Delta's work performance.

Approval of the motion would extend the contract for the fourth and final time in the amount of \$71,000, term to expire 12/31/02. Because the total now exceeds \$200,000, the contract extension is being brought to the Finance Committee for approval.

# **CONSEQUENCES OF DELAY**

The COP will be without independent support as of 1/1/02.

A motion of the Finance Committee of the Central Puget Sound Regional Transit Authority authorizing the Executive Director to execute the fourth and final contract extension with Prospect Delta to provide independent support for the Citizen Oversight Panel.

## Background:
