A motion of the Finance Committee of the Central Puget Sound Regional Transit Authority authorizing the Executive Director to execute a contract amendment with Emerald Services, for the environmental remediation of the Chevron site on the Tacoma Link Light Rail alignment in the amount of \$2,815 for a new authorized contract amount not to exceed \$202,091.

## **Background:**

The Tacoma Link Light Rail project consists of 1.6 miles of at-grade light rail, and 5 stations, in the heart of downtown Tacoma. Construction began in January 2001, and operations will begin in September 2003. The total project budget is \$80.4M and the construction is 30% complete.

A Chevron station at the intersection of 17<sup>th</sup> Street and Pacific Avenue was acquired by Sound Transit as part of the necessary right-of-way. Upon completion of the light rail construction, portions of the property will be used by the City of Tacoma for the construction of an urban park. Sound Transit developed a plan for the environmental remediation of three underground storage tanks and surrounding soils.

To achieve small business goals on the project, a small contract was competitively bid in 2000, for the removal of the tanks and contaminated soils. Being under \$200,000 the contract was awarded by action of the Executive Director. During construction in the summer of 2001 a fourth storage tank was discovered and removed at the direction of the Department of Ecology. This expanded scope resulted in the contract contingency being exceeded. Finance Committee action is requested to authorize the Executive Director to execute an amendment to the existing contract for a total contract amount of \$202,090.86 to cover the costs removing the fourth storage tank.

## **Objective of Action**

 Authorizes supplemental funding, in the amount of \$2,815, to close out Contract RTA/171-00 with Emerald Services for Tacoma Link Light Rail Environmental Remediation.

#### <u>Action</u>

 Authorizes the Executive Director to execute a contract amendment with Emerald Services, Contract RTA/171-00 for the environmental remediation of the Chevron site on the Tacoma Link Light Rail alignment in the amount of \$2,815 for a new authorized contract amount not to exceed \$202,091.

## **Key Features**

- Authorizes the Executive Director to amend the contract with Emerald Services for environmental remediation of the Chevron site
  on the Tacoma Link Light Rail alignment.
- Authorizes an additional \$2,815 to the original contract amount of \$199,275, for a total amended authorized contract amount of \$202,091 for added scope of work.
- Funds previously authorized by the Executive Director included \$183,664 with a contingency of \$15,611 for a total initial authorization of \$199,275.
- The original allocated contingency of 8.5% was exceeded due to the discovery and subsequent removal of a fourth previously unidentified underground storage tank on the property.

#### **Budget**

The 2002 Board-adopted budget, as amended, for Tacoma Link capital construction is \$80,416,000. Within that amount, \$49,498,550 is budgeted for construction and \$249,275 was budgeted for this activity. There are sufficient funds to award this contract amendment for a total amount of \$202,090. With the award of this contract, there is sufficient budget remaining to complete the project.
