OBJECTIVE OF ACTION

• To gain Board approval for a sole source contract with Talking Signs® for a Remote Infrared Audible Signs (RIAS) Wayfinding Demonstration Project.

ACTION

Authorize the Executive Director to execute a sole source contract with Talking Signs® Services, Inc. to provide consulting and technical services for Remote Infrared Audible Signs (RIAS) Wayfinding Demonstration Project in the amount of \$135,000, with a 10% contingency amount of \$13,500, for a total authorized contract amount not to exceed \$148,500.

KEY FEATURES

- Approval of the sole source contract with Talking Signs®, will enable staff to move forward
 with finalizing the project agreements to implement the RIAS demonstration project during
 the first half of 2003. The demonstration project will provide data to assist Sound Transit in
 determining the feasibility and cost effectiveness of Sound Transit's installation of this
 wayfinding technology in the future.
- Sound Transit's Regional Accessibility Plan was created to increase mobility and accessibility for all transit users. Within the Accessibility Plan is the "Mobility Initiative Program" (MIP) which includes the Infrared Wayfinding Demonstration Project. The Sound Transit Board funded the MIP on May 10, 2001, as part of the 2001 Service Implementation

Plan. Partial funding for the demonstration project was included in the Board approved 2002 budget. The remaining funds have been requested in the 2003 budget.

- Talking Signs® is the sole manufacturer of infrared technology that meets the Americans with Disabilities Act Accessibility Guidelines. Talking Signs® Services is the sole distributor and installer of Talking Signs® technology for the State of Washington.
- King County Metro and Amtrak are not charging Sound Transit to install the Talking Signs® technology at King Street Station and at the International District Station in the downtown Seattle tunnel. King County Metro will provide technical staff support during the testing phase of the project and administrative staff support during the compiling of results of the project.

REVENUE, SUBAREA, AND FINANCIAL PLAN IMPACTS

 The proposed action is consistent with the current Board-adopted budget and is affordable within Sound Transit's current long-term financial plan and the subarea financial capacity.

M/W/DBE - SMALL BUSINESS PARTICIPATION

 Due to the narrow scope and proprietary nature of the technical specifications, subcontracting is infeasible. As a result, Talking Signs® will not be required to submit a small business participation plan to perform on the demonstration project. Sound Transit may revisit the question of subcontracting opportunities if, after the demonstration project is complete, a decision is made to purchase and install this technology.

PROJECT DESCRIPTION

Talking Signs® is a system of infrared transmitters and receivers used by the blind, visually impaired and persons with cognitive disabilities to identify environmental features such as wayfinding, bus stops, and intermodal transfers. It makes independent travel more convenient and safe for vision impaired and print-handicapped individuals.

The demonstration project will have the technology installed at King Street Station at the Sounder commuter rail and Amtrak rail platforms and at the International District Station in the downtown tunnel. Talking Signs® technology is compatible with smart bus/next bus technology which has been tested by Sound Transit and King County Metro.

CONSEQUENCES OF DELAY

• The demonstration project can not be conducted without Board approval of a sole-source contract.

REGIONAL PARTNERSHIP AND COOPERATION

- Upon approval of the Talking Signs® contract, Sound Transit will develop a Memorandum of Agreement with Washington State Department of Transportation, Amtrak and King County Metro to outline use of the facilities.
- Sound Transit's Citizens Accessibility Advisory Committee (CAAC), members of the deafblind working group from the Light house for the Blind and the transit partners will be invited to have members of their accessibility advisory committees participate in the testing.

PUBLIC INVOLVEMENT

- The Remote Infrared Audible Signs Demonstration Project was identified as an integral component of the Mobility Initiative Program at workshops conducted with the CAAC and during public outreach meetings held in 2000.
- As part of the evaluation process, Sound Transit will have a group of blind, visually-impaired, and cognitively-impaired riders test the technology. Staff will use the data collected during the demonstration project to evaluate the effectiveness of implementing this wayfinding technology in the future.

A motion of the Board of the Central Puget Sound Regional Transit Authority authorizing the Executive Director to execute a sole source contract with Talking Signs® Services, Inc. to provide consulting and technical services for Remote Infrared Audible Signs (RIAS) Wayfinding Demonstration Project in the amount of \$135,000, with a 10% contingency amount of \$13,500 for a total authorized amount not to exceed \$148,500.

Background:

Sound Transit's Regional Accessibility Plan was created to increase mobility and accessibility for all transit users. Within the Accessibility Plan is the "Mobility Initiative Program" (MIP) which includes the Infrared Wayfinding Demonstration Project. The MIP was funded by the Sound Transit Board on May 10, 2001 as part of the 2001 Service Implementation Plan.

Talking Signs® is a system of infrared transmitters and receivers used by the blind, visually impaired, and persons with cognitive disabilities to identify environmental features to make more independent travel possible. The technology will be installed at King Street Station and at the International District Station in the downtown tunnel. Talking Signs® technology is compatible with smart bus/next bus technology which has been tested by Sound Transit and King County Metro.

As part of the evaluation process, Sound Transit will have a group of blind, visually impaired, and cognitively impaired riders test the technology. Staff will use the data collected during the demonstration project to evaluate the effectiveness of implementing this wayfinding technology in the future.
