OBJECTIVE OF ACTION

• To exercise the last of three options to extend the Management Systems Contract with KJM & Associates, Inc. for six months and to add additional funds to continue this scope of work.

ACTION

 Authorizes the Executive Director to exercise a third and final option to extend the contract with KJM & Associates, Inc. to provide support services for an additional six-month term in the amount of \$1,045,533, with a 10% contingency of \$104,553, for a total authorized amount of \$1,150,086, and a new total authorized contract amount not to exceed \$13,378,776.

KEY FEATURES

- Revises the scope of the contract to reflect Sound Transit's management systems support needs for the next six months.
- Ensures adequate management systems support to all Sound Transit departments to assist in meeting the requirements defined in the Sound Move Program Management Plan.
- Exercises a third and final option to extend the contract with KJM & Associates, Inc. to provide support services for an additional six-month term.

M/W/DBE - SMALL BUSINESS PARTICIPATION

M/W/DBE firms will perform 100% of the work on this contract amendment. KJM is a WBE certified by the State of Washington. They will perform 81.5% of this contract amendment. All of their subcontractors are also M/W/DBE firms performing the remaining 18.5% of the work on this contract amendment. These levels are consistent with the overall performance of KJM and its subcontractors on this contract.

HISTORY OF PROJECT

On April 9, 1998, the Board approved Resolution No. 98-14 authorizing a contract with KJM & Associates, Inc. for the development, installation, and maintenance of a management reporting and project control system for Sound Move. Additionally, the contract provided for dedicated project control resources for Link Light Rail, Sounder Commuter Rail, and Regional Express bus. The original amount of the contract was \$5,793,821 with a contingency of \$1,898,764 resulting in a total authorized amount not to exceed \$7,692,585. The term of the contract was two years with three, one-year options.

On May 25, 2000, the Board approved Motion No. M2000-42 authorizing a contract amendment with KJM & Associates, Inc. exercising the first of three, one-year contract options to continue providing project control support services to Sound Transit. The scope of that amendment included the development of agency policies and procedures, assistance with agency reporting, support in implementing the agency's financial/project management systems, document management, MIS support, scheduling, and cost control. Support was provided to Link Light Rail, Sounder Commuter Rail, and Regional Express bus and was coordinated by the agency Project Control Manager. The value of this amendment was \$1,778,771 with a contingency of \$177,877 for a total authorized amount not to exceed \$1,956,648.

On June 28, 2001, the Board approved Motion No. M2001-60 authorizing a contract amendment with KJM & Associates, Inc. exercising the second of three, one-year contract options to continue providing project control support services to Sound Transit. The scope of that amendment included the development and revisions of agency policies and procedures, assistance with agency reporting, support in implementing the agency's project control system, document management, MIS support, scheduling, and cost and project control support. Support was provided to Link Light Rail, Sounder Commuter Rail, Regional Express bus, supporting departments and divisions. This effort was coordinated by the agency Project Control Manager. The value of this amendment was \$2,344,961 with a contingency of \$234,496 for a total authorized amount not to exceed \$2,579,457.

In preparing for this action, Sound Transit staff has conducted an assessment to determine the management systems support needs for each department. Included within this contract amendment are scope tasks deemed necessary to cover those needs. This action will provide support to Link Light Rail, Sounder Commuter Rail, Regional Express and agency-wide project control. Specific areas covered include project control support and reporting, diversity reporting, document management, MIS and computer support and contract administration support. Included is the flexibility to respond to specific project control needs as they arise within the next six months. The Agency Project Control Manager will manage this contract.

A motion of the Board of the Central Puget Sound Regional Transit Authority authorizing the Executive Director to exercise a third and final option to extend the contract with KJM & Associates, Inc. to provide support services for an additional six month term and in the amount of \$1,045,533, with a 10% contingency of \$104,553, for a total amount of \$1,150,086, and a new total authorized contract amount not to exceed \$13,378,776.

Background:

On April 9, 1998, the Board approved Resolution No. 98-14 authorizing a contract with KJM & Associates, Inc., for the development, installation, and maintenance of a management reporting and project control system for Sound Move. Additionally, the contract provided for dedicated project control resources for Link Light Rail, Sounder Commuter Rail, and Regional Express bus. The original amount of the contract was \$5,793,821 with a contingency of \$1,898,764 resulting in a total authorized amount not to exceed \$7,692,585. The term of the contract was two years with three, one-year options.

On May 25, 2000, the Board approved Motion No. M2000-42 authorizing a contract amendment with KJM & Associates, Inc. exercising the first of three, one-year contract options to continue providing project control support services to Sound Transit. The scope of that amendment included the development of agency policies and procedures, assistance with agency reporting, support in implementing the agency's financial/project management systems, document management, MIS support, scheduling, and cost control. Support was provided to Link Light Rail, Sounder Commuter Rail, and Regional Express bus and was coordinated by the agency Project Control Manager. The value of this amendment was \$1,778,771 with a contingency of \$177,877 for a total authorized amount not to exceed \$1,956,648.

On June 28, 2001, the Board approved Motion No. M2001-60 authorizing a contract amendment with KJM & Associates, Inc. exercising the second of three, one-year contract options to continue providing project control support services to Sound Transit. The scope of that amendment included the development and revisions of agency policies and procedures, assistance with agency reporting, support in implementing the agency's project control system, document management, MIS support, scheduling, and cost and project control support. Support was provided to Link Light Rail, Sounder Commuter Rail, Regional Express bus, supporting departments and divisions. This effort was coordinated by the agency Project Control Manager. The value of this amendment was \$2,344,961 with a contingency of \$234,496 for a total authorized amount not to exceed \$2,579,457.

In preparing for this action, Sound Transit staff has conducted an assessment to determine the management systems support needs for each department. Included within this contract amendment are scope tasks deemed necessary to cover those needs. This action will provide support to Link Light Rail, Sounder Commuter Rail, Regional Express and agency-wide project control. Specific areas covered include project control support and reporting, diversity reporting, document management, MIS and computer support and contract administration support. Included is the flexibility to respond to specific project control needs as they arise within the next six months. The Agency Project Control Manager will manage this contract.

It is hereby moved by the Board of the Central Puget Sound Regional Transit Authority that the Executive Director is authorized to exercise a third and final option to extend the contract with KJM & Associates, Inc. to provide support services for an additional six-month term in the amount of \$1,045,533, with a 10% contingency of \$104,553, for a new total authorized contract amount not to exceed \$13,378,776.
