OBJECTIVE OF ACTION

To add on-call support and consulting services to the existing contract with Karl Haberl, dba Critical Path Systems Consultants, to complete integral tasks in support of the integration between the Agency Project Control Management System and Financial System, and to complete essential agency project control tasks through December 31, 2002.

ACTION

Authorize the Executive Director to execute a contract amendment with Karl Haberl, dba Critical Path Systems Consultants, to provide additional on-call consulting services to complete critical tasks in support of the integration of the Agency Project Control Management System and Financial System, adding the amount of \$70,000 for a total contract amount not to exceed \$419,000.

KEY FEATURES

- Provides for timely completion of the project control management system implementation and transfer of knowledge from consultant to Sound Transit staff.
- Tasks yet to be concluded include completing software functionality implementation and testing, documenting business processes and procedures, handing off project knowledge to newly hired Sound Transit staff and supporting the agency project control manager in the development of the project control function.
- Resources for these additional tasks were not included in the contract amendment approved in May 2002 because it was anticipated another vendor would complete these tasks. However, this consultant has demonstrated they have the capacity, expertise and

knowledge needed by the agency to complete the implementation of the agency project control function.

HISTORY OF PROJECT

On-Call consulting services with Karl Haberl, dba Critical Path Systems Consultants, were obtained through a competitive procurement in June of 2001, for a one-year period with options for three one-year extensions, in the amount of \$150,000. In February of 2002 an additional \$49,000 was added to the contract amount to bring it to a new total of \$199,000.

In May of 2002, the agency exercised the first option to extend the contract through December 31, 2002, and added \$150,000 to continue on-call support and consulting services to maintain existing Access databases, troubleshoot and support the JD Edwards database and support the JD Edwards integration to the Agency Project Control Management System.

Detailed Contract Scope includes: DataMirror Replacement, Enhance Previous Period Refresh, Synchronization with Accounting Cycle, Data Integrity Validation, Contract Locking during Validation, Regional Express Conversions, Sounder Conversions, Reporting Troubleshooting and Support, Finalize User Documentation, Create Support Documentation, Create Technical Documentation, Creating Credit Memos in Expedition, Tracking Betterments, Enhancements to Current Diversity Tracking System, ROW Conversions, Legal Conversions, Other non-LOB Conversions, Security Enhancements, Other Enhancements, Integration Auditing Features, Enhance Reporting Speed, Allow for early closure of Reporting Cycle, Handling Tax in Expedition, Handling Retainage in Expedition, Correcting for Rounding Errors.

- Delay in approving this amendment will leave agency personnel without resources for specific system and process related project control support.
- Completion of initial functionality of the Project Control reporting portal would be delayed, resulting in a delay in the completion of the implementation of the Agency Project Management System.

A motion of the Finance Committee of the Central Puget Sound Regional Transit Authority authorizing the Executive Director to execute a contract amendment with Karl Haberl, dba, Critical Path Systems Consultants for on-call support and consulting services in the amount of \$70,000, for a new total authorized contract amount not to exceed \$419,000.

Background:

On-Call consulting services with Karl Haberl, dba, Critical Path Systems Consultants were obtained through a competitive procurement in June of 2001, for a one-year period with options for three one-year extensions, in the amount of \$150,000. In February of 2002 an additional \$49,000 was added to the contract amount to bring it to a new total of \$199,000.

In May of 2002, the agency exercised the first option to extend the contract through December 31, 2002, and added \$150,000 to continue on-call support and consulting services to maintain existing Access databases, troubleshoot and support the financial database and support the financial system integration to the Agency Project Control Management System.

This action proposes to add on-call support and consulting services to the existing contract. Tasks to be completed include completing software functionality needs, documenting business processes and procedures, handing off project knowledge to newly hired staff and supporting the agency project control manager in the project control function.

Motion:

It is hereby moved by the Finance Committee of the Central Puget Sound Regional Transit Authority that the Executive Director is authorized to execute a contract amendment with Karl Haberl, dba, Critical Path Systems Consultants for on-call support and consulting services in the amount of \$70,000, for a new total authorized contract amount not to exceed \$419,000.
