# **OBJECTIVE OF ACTION**

• To complete Final Design and prepare Plans, Specifications, and Estimates (PS&E) for the Kirkland HOV Direct Access Ramp Project (#140).

# **ACTION**

 Authorizes the Executive Director to execute a project level agreement with the Washington State Department of Transportation (WSDOT) for the completion of final design and preparation of PS&E for the Kirkland HOV Direct Access Ramp Project in the amount of \$4,097,024, with a 10% contingency of \$409,702, for a total authorized amount not to exceed \$4,506,726.

- Enables Sound Transit to enter into an agreement with WSDOT for completion of final design of the project.
- This scope of services for this Agreement includes development of PS&E necessary for the construction of the project.

# Prior Board or Committee Actions and Relevant Board Policies

The Kirkland/I-405 Direct Access Project is one of several Sound Move projects that have been combined together and called the Regional Express Kirkland Project. The other project in this grouping is the Totem Lake Transit Center Project (#328, formerly known as the Kirkland Transit Center). Although these projects are identified in Sound Transit's budget as two separate projects, they have been treated as one project for the preliminary engineering and environmental documentation phase. The Kirkland HOV Direct Access project will serve the Kingsgate Park-and-Ride Lot and the proposed transit center located on the Evergreen Hospital campus by providing direct access to and from the HOV lanes on I-405 at NE 128th Street. It is expected that the installation of this HOV direct access ramp will improve transit speed and reliability and improve safety along the corridor.

An Environmental Assessment (EA) was prepared for the direct access and transit center projects in compliance with the National Environmental Policy Act (NEPA). The EA was issued in May 2002 and the Federal Highway Administration (FHWA) and Federal Transit Administration (FTA) issued a Finding of No Significant Impact (FONSI) on November 13, 2002. The EA and FONSI were adopted under SEPA and the Determination of Non-Significant Impact (DNS) was issued on November 13, 2002. With issuance of the FONSI and DNS, this project is ready to move forward to the final design phase.

Sound Move states that "actual design and construction of all HOV lanes and ramps will be done by the State Transportation Department." This requires Sound Transit to enter into an agreement with WSDOT for completion of final design of this project. The scope of services for this agreement will include development of PS&E necessary for construction of this project. At the completion of final design, Sound Transit and WSDOT will enter into a task order agreement for construction and construction management of the project under the Umbrella Agreement that was approved by the Board and September 13, 2002.

The final design and PS&E, securing the necessary permits and approval, and acquiring the needed right-of-way should be complete by December 2003. It is anticipated that construction will begin in early 2004.

# **REGIONAL PARTNERSHIP AND COOPERATION**

A Project Management Team and an Executive Advisory Committee have been established for the Kirkland I-405 HOV Access Improvements project to assist staff in making project decision. The Project Management Team is comprised of technical staff from Sound Transit, WSDOT, City of Kirkland, and King County Metro. The Executive Advisory Committee is comprised of elected officials, key agency management staff, and city business and community leaders, whose responsibility is to advise Sound Transit on the Kirkland projects.

The EAC will be disbanded at the completion of PE/ED and resolution of major planning issues. The PMT will be continued in a different format.

Sound Transit worked with WSDOT, FTA, and FHWA to process the FONSI.

Sound Transit worked with WSDOT to process the DNS.

## PUBLIC INVOLVEMENT

Sound Transit and its project partners (City of Kirkland, WSDOT, and King County Metro) have hosted four public open houses to present ideas about the proposed transit improvements in the Kirkland area. Overall feedback from the open houses has been positive.

The public is encouraged to call or email Sound Transit at any stage of the project to request information or to provide comments.
