In February 1998, the Sound Transit Board authorized the Executive Director to execute a contract with Parametrix, Inc., to provide environmental review services for the Central and Tacoma Link Light Rail projects for an amount of \$5,294,819 (including contingency). The contract was amended in September 1999 to a total authorized amount of \$6,809,819 in additional funds necessary to complete the final EIS, to provide support during legal appeals and to support the environmental permitting process. In February 2001, the contract was again amended to a new total authorized amount of \$7,414,819 for additional environmental review services for Central Link and the Tukwila Freeway Route.

During 2001, Sound Transit re-examined the Central Link project and on September 27, 2001, by Motion No. M2001-103, the Sound Transit Board identified a 14-mile preferred initial segment to be constructed and operated for the Central Link light rail project from Convention Place in downtown Seattle to South 154th Street. The Board made the final decision on selecting the initial segment on November 29, 2001 by Resolution No. R2001-16.

During selection of the initial segment, the Sound Transit Board had expressed a consistent commitment to building the entire Central Link light rail project from SeaTac to Northgate. Therefore, also on September 27, 2001, by Motion No. M2001-104, the Board authorized staff to complete an 18- to 24-month supplemental EIS and design effort to analyze alternative routes to the north of the initial segment interim terminus at Convention Place.

This proposed action is to revise the contract scope of work and increase the contract amount for the environmental services consulting contract with Parametrix, Inc., in the amount of \$1,810,365 and a 10% contingency of \$181,037 for a total contract amendment amount not to exceed \$1,991,402.

The work performed under this contract provides compliance for the Link Light Rail Project under federal, state, and local environmental regulations. Timely completion of this process is a necessary step to implement the North Link portion of the Link Light Rail Project, to meet the commitments of the Sound Move plan, and obtain federal funding. Objective of Action

• To complete the North Link Supplemental Environmental Impact Statement (SEIS) in order to select a Link light rail route north of Convention Place.

<u>Action</u>

 Authorize the Executive Director to execute a contract amendment with Parametrix for completion of a North Link SEIS in the amount of \$1,810,365 and a 10% contingency of \$181,037 for a total contract amendment amount not to exceed \$1,991,402 and a total revised contract amount not to exceed \$9,406,221.

Key Features

- Establishes a contract amendment with Parametrix in the amount of \$1,810,365 and a 10% contingency of \$181,037 for a total contract amendment amount not to exceed \$1,991,402 and a total revised contract amount not to exceed \$9,406,221.
- Provides for completion of the North Link SEIS and related environmental studies.
- Includes an M/W/DBE participation goal of 21%. To date the contract has achieved an M/W/DBE participation of 25%. This amendment proposes participation of 25% also.

<u>Budget</u>

On September 27, 2001, the Board adopted Motion No. M2001-104 that directed staff to evaluate routes and station alternatives between Convention Place Station (CPS) and Northgate. In conjunction with that motion, a budget of \$21 million was identified for the two-year work-plan.

On December 13, 2001, the Board adopted the 2002 agency budget. The total budget for the segment from CPS to Northgate (as identified in Amendment 9) is \$110 million, which includes the \$21 million for future work, as well as an estimate of expenditures for work already completed in this area.

Within the \$21 million budget for the two-year work plan, \$2,150,000 was identified for future environmental work as contemplated in this motion.

To date, the Board has authorized commitments totaling \$7,414,819 with Parametrix for work on the Link Light Rail program. Previous work under this contract occurred across the Central Link and the Tacoma Link projects, including the North Link segment. These

historic costs are budgeted for under separate line items within the projects and are not included within this task budget. With this action, the new total authorized contract amount will be \$9,406,221.

History of Project

In February 1998, the Sound Transit Board authorized the Executive Director to execute a contract with Parametrix, Inc., to provide environmental review services for the Central and Tacoma Link Light Rail projects for an amount of \$5,294,819 (including contingency). The contract was amended in September 1999 to a total authorized amount of \$6,809,819 to provide additional funds necessary to complete the final EIS, to provide support during legal appeals and to support the environmental permitting process. In February 2001, the contract was again amended to a new total authorized amount of \$7,414,819 for additional environmental review services for Central Link and the Tukwila Freeway Route.

The Parametrix, Inc. team has involved 30 different consultant firms over the life of the contract. The work performed to date has consistently been good quality and met Sound Transit's aggressive schedules.

During 2001, Sound Transit re-examined the Central Link project and on September 27, 2001, by Motion No. M2001-103, the Sound Transit Board identified a 14-mile preferred initial segment to be constructed and operated for the Central Link light rail project from Convention Place in downtown Seattle to South 154th Street. The Board made the final decision on selecting the initial segment on November 29, 2001 by Resolution No. R2001-16.

During selection of the initial segment, the Sound Transit Board had expressed a consistent commitment to building the entire Central Link light rail project from SeaTac to Northgate. The work performed under this contract provides compliance for the Link Light Rail Project under federal, state, and local environmental regulations. Timely completion of this process is a necessary step to implement the North Link portion of the Link Light Rail Project and obtain federal funding.

The additional scope of work includes services during the supplemental EIS scoping and screening process, completion of the draft and final supplemental EIS, other environmental studies associated with the supplemental EIS process, and preparation of the federal record of decision for North Link from Convention Place to Northgate.

Completion of the North Link SEIS will extend this contract past 5 years in early 2003. Federal contracting rules limit the length for this type of contract to 5 years, unless a waiver is obtained from the Federal Transit Administration. A waiver has been requested and is anticipated prior to execution of this amendment.
