### **OBJECTIVE OF ACTION**

To provide Traffic signal controllers and cabinets for the Tacoma Link Light Rail Project

### **ACTION**

 Authorizes the Executive Director to execute a sole source contract with Northwest Signal Supply Company to provide 19 signal controllers and cabinets for the Tacoma Link Light Rail Project in the amount of \$339,120 with a contingency of \$5,000 for a total authorized amount not to exceed \$344,120.

## **KEY FEATURES**

- Provides for new controllers and cabinets required for the interface between vehicular traffic and light rail trains for 17 intersections along the light rail route in the City of Tacoma.
- Northwest Signal Supply company is the City of Tacoma's sole source supplier of traffic signal controllers and cabinets.
- Authorizes the Executive Director to execute a sole source contract with Northwest Signal Supply Company to provide 19 signal controllers and cabinets for the Tacoma Link Light Rail Project in the amount of \$339,120 with a contingency of \$5,000 for a total authorized amount not to exceed \$344,120.
- Northwest Signal Supply company is the sole supplier for PEEK controllers in the region.

Traffic controllers and cabinets are required for the interface between vehicular traffic and light rail trains for 17 intersections along the light rail route in the City of Tacoma.

These controllers are a sole source acquisition with Northwest Signal Supply Company because:

- No other controllers are compatible with City of Tacoma's equipment within this corridor of the City.
- The City of Tacoma will be able to maintain these controllers as part of it's existing maintenance program.

The existing signal controllers in Tacoma do not have the capabilities necessary to accommodate light rail operation. The City owns and operates only PEEK controllers. Other controllers identified as being capable of accommodating light rail software were not compatible with existing equipment and would not be approved by the City for installation.

### **CONSEQUENCES OF DELAY**

- Delaying procurement and installation of the permanent traffic control and light rail intersections within City of Tacoma.
- Cost and Schedule increase to Tacoma Link light Rail Project as temporary signal cabinets will have to be put in and then replaced with permanent cabinets.
- Impact to the community with having added traffic control through intersection to replace temporary cabinets.

# **REGIONAL PARTNERSHIP AND COOPERATION**

- The City of Tacoma aided Sound Transit in developing a traffic signal controller that will be compatible with their existing system and the advent of link light rail.
- The City of Tacoma will perform environmental and functional testing on the signal controllers prior to delivery to the Tacoma Link Light Rail Contractor.
