## Background:

In July 2001, Sound Transit advertised and issued an Invitation for Bids for agency wide copying services. Sound Transit received eight bids on August 23, 2001. One protest was lodged, appealed and ruled upon by the Sound Transit Executive Director.

The contract award is made to the lowest, responsive and responsible bidder, Royal ReproGraphics, at a comparison price bid proposal of \$305,670.50.

The contractor will provide photocopying, binding, mounting, laminating, and CD duplication services that the agency is not able to complete in-house.
