OBJECTIVE OF ACTION

• The proposed site of the Central Operations and Maintenance (O&M) Facility for Central Link needs to be prepared in advance of facility construction through demolition and removal of existing building structures and remediation of existing hazardous and contaminated materials.

ACTION

• Authorize the Executive Director to execute a contract with R.W. Rhine for site preparation of the Central Operations and Maintenance (O&M) Facility for Central Link in the amount of \$4,336,821 plus a 15% contingency of \$650,523 for a total authorized amount not to exceed \$4,987,344.

KEY FEATURES

- Authorizes the Executive Director to execute a contract with R.W. Rhine for preparation of the Central O&M Facility site for the Central Link Light Rail Project.
- Authorizes a contract amount of \$4,336,821 plus a 15% contingency of \$650,523 for a total amount not to exceed \$4,987,344.
- Staff recommends a contingency of 15% (in lieu of the standard 10%) in order to address the uncertainties regarding the exact nature and extent of hazardous materials expected to be discovered.
- Contract will not be awarded until Sound Transit receives a Letter of No Prejudice from the FTA.

BUDGET DISCUSSION

The total capital budget for the Initial Segment from CPS to South 154th is \$2.07 billion. Within that budget, the activity contemplated within this motion is identified within the Construction phase. This activity was included within the cost estimate and there are sufficient funds identified for work identified in this motion. The budget for this activity is \$15,200,000. There is a remaining budget surplus of \$10,212,656 for this activity. With the award of this contract, there is sufficient budget remaining to complete the project.

REVENUE, SUBAREA, AND FINANCIAL PLAN IMPACTS

The proposed action is consistent with the current board adopted budget and is affordable within the agency's current long-term financial plan and subarea financial capacity. The action will have no new revenue impacts on Sound Transit.

HISTORY OF PROJECT

Sound Transit issued an Invitation for Bids for Site Preparation for the Central O&M Facility, Contract C600. The scope of work involved in the Invitation for Bid included removal of hazardous materials from buildings, demolition and removal of building structures, installing security fencing, removal of underground storage tanks, and remediation of petroleum contaminated soil and groundwater on the site. On April 4, 2002, Sound Transit received bids from six firms for the C600 contract and determined that R.W. Rhine was the lowest responsive and responsible bidder. The Engineer's estimate for the work in this contract was \$12,861,600, but did not consider cost savings associated with the salvage of recovered materials. Work on this contract will start in summer 2002 and be completed in February 2003.

CONSEQUENCES OF DELAY

Delaying the award of this contract would delay the scheduled start dates for construction of the light rail line along the E-3 Busway/Forest Street and the Central O&M Facility. Construction of the Central O&M Facility for the Central Link project is scheduled to commence in March 2003 and to be completed in June 2005. Construction of the line segment from Royal Brougham Way to Airport Way South is scheduled to commence in November 2002 and to be completed in April 2005.

Background:
