BUDGET DISCUSSION

The recommendation will result in a revised budget for the Research and Technology Program. The 2002 budget would be reduced by approximately \$2 million and the 2002-2006 budget by approximately \$19 million. These dollars would then be available for redistribution from the Regional Fund for other needs.

REVENUE, SUBAREA, AND FINANCIAL PLAN IMPACTS

The Regional Fund was established by proportional contributions from each subareas revenues. Deferral and/or changes in project direction within the Regional Fund, such as proposed for Research and Technology, will require further action to reallocate those resources.

Regional Partnership and Cooperation

Fare Integration, Research and Technology and Phase II Planning are all projects that involve discussion with transit partners and other outside agencies. The disposition of these funds has been watched very closely by many of these partners. Fare Integration involves a multi-agency agreement between the five existing transit agencies in the Sound Transit district; the Regional Transit Technology Group was established in order to better coordinate transit agency technology initiatives and finally Phase II has been a keen topic of interest for subarea groups such as ETP. It is expected that decisions related to these regional fund projects will be subject of future discussion with these groups.

Public Involvement

Some outreach related to Phase II Planning has been conducted as a part of the Trans-Lake Washington and I-405 EIS projects.

DESCRIPTION OF POLICY

- 1. One policy change currently identified is the reduction to the Research and Technology budget and previous board actions establishing the Alternative Transit Technologies and Transit Systems Enhancement sub categories. The RFTF has recommended a total budget reduction of approximately \$19 million, and at a later date, staff will process the appropriate change to Sound Move.
- 2. Another policy change is the timing of the Phase II vote from 2004 to a date now unspecified. Direction to staff is to hire a Phase II consultant and scope their work program such that staff can respond to a number of potential future vote dates.

A motion of the Board of the Central Puget Sound Regional Transit Authority to adopt the Regional Fund Task Force recommendations.

Background:

On February 7, 2002, the Executive Committee created the Regional Fund Task Force (RFTF), comprised of one member from each subarea, to discuss issues related to projects identified in the Regional Fund. Through a series of three meetings, the RFTF reviewed the entire program and discussed a range of issues primarily focused on the current work programs for Fare Integration, Research and Technology, and Phase II Planning. The RFTF has now outlined a series of recommendations and proposed future actions regarding the Regional Fund.
