## **OBJECTIVE OF ACTION**

To enter into an intergovernmental agreement with the City of Tacoma for Tacoma Link Light Rail Alignment Area Roadway and Streetscape Improvements.

## **ACTION**

Authorizes the Chief Executive Officer to execute an intergovernmental agreement with the City of Tacoma for Tacoma Link Light Rail Alignment Area Roadway and Streetscape Improvements, for a total amount not to exceed \$786,795.

The agreement also includes the transfer of \$142,613 from the City of Tacoma (Arterial Street Fund 1060) to Sound Transit, plus the transfer of \$22,810 from the City of Tacoma to Sound Transit for sewer betterments, for a total transfer amount of \$165,423.

## **KEY FEATURES**

- Sound Transit pays City of Tacoma \$786,795 for various urban improvements, including the Park Plaza and Hillclimb projects (per Motion No. M99-28, dated July 8, 1999).
- City of Tacoma pays Sound Transit \$142,613 from their Arterial Street Fund 1060 for construction of paving on Pacific Avenue between 20th and 23rd Streets.
- City of Tacoma pays Sound Transit \$22,810 for sewer betterments constructed by Sound Transit.

# BUDGET IMPACT SUMMARY

There is no action outside of the Board-adopted budget; there are no contingency funds required, no subarea impacts, or funding required from other parties other than what is already assumed in the financial plan.

## **BUDGET DISCUSSION**

This intergovernmental agreement covers various roadway and streetscape improvements along the Tacoma Link alignment as follows:

Pay the City of Tacoma \$786,795 for various urban improvements per Sound Transit Board Motion No. M99-28. These activities are included within the Sound Transit budget for Tacoma Link as a line item of \$790,000 within the construction phase.

Receive payment of \$165,423 from the City of Tacoma for paving improvements on Pacific Avenue between 20th Street and 23rd Street and sewer betterments. This work was performed by Sound Transit under the Tacoma Link Civil Construction (C910) contract.

## **REVENUE, SUBAREA, AND FINANCIAL PLAN IMPACTS**

The total 2003 Board-adopted budget for Tacoma Link is \$80.4 million. The proposed action is consistent with the current project forecast and is affordable within the agency's current long-term financial plan and subarea financial capacity.

Both Sound Transit and the City of Tacoma have received state and federal grants to enhance the project. This agreement formalizes a series of financial transactions necessary to transfer grant monies and to equitably fund portions of the work.

Transfer of grant funds from the City of Tacoma to Sound Transit involved in this action will provide additional revenue to Sound Transit for paving improvements.

Sound Transit has worked cooperatively with the City of Tacoma, Pierce Transit, local businesses and interest groups on the Tacoma Link Light Rail Project. The ongoing cooperation and teamwork exhibited by these groups has been critical to the success of the project.

## PUBLIC INVOLVEMENT

Sound Transit staff continues to keep local and area residents informed about the status of the project and the impact of construction on the neighborhoods.
