OBJECTIVE OF ACTION

To construct light rail improvements for Contract C700 (E-3 Busway/Forest Street) between South Royal Brougham Way and Airport Way South, as the first major construction contract of the Link Initial Segment.

ACTION

Authorize the Chief Executive Officer to execute a contract with Kiewit Pacific Company for the construction of Contract C700 (E-3 Busway/Forest Street), in the amount of \$40,691,061 with a 10% contingency of \$4,069,106, for a total authorized contract amount not to exceed \$44,760,167, subject to the execution of the Full Funding Grant Agreement.

KEY FEATURES

- This contract includes at-grade and elevated trackway along the E-3 Busway and South Forest Street, a light rail station at South Lander Street, and a connection to the new light rail Operations and Maintenance Facility at the former Rainier Brewery site along Airport Way South. Also included is the provision for a future station at South Royal Brougham Way.
- Award of this contract is subject to execution of the Full Funding Grant Agreement.
- Identifies Kiewit Pacific Company as the lowest responsive and responsible bidder.

BUDGET IMPACT SUMMARY

There are no budget impacts for this action.

BUDGET DISCUSSION

The proposed action is to authorize execution of a contract with Kiewit Pacific Company in an amount not to exceed \$44,760,167 for construction of Contract C700 (E-3 Busway/Forest Street) between South Royal Brougham Way and Airport Way South.

The total adopted capital budget for the Initial Segment is \$2.07 billion. Within that budget, \$54,112,000 was set aside in the construction phase for this contract. This amount was reduced to \$51,748,514 through previous board actions that authorized selected advance construction activities, including the widening of the E-3 busway and selected utility relocations. Should the proposed action be approved, this budget line item will have a remaining balance of \$6,988,347.

REVENUE, SUBAREA, AND FINANCIAL PLAN IMPACTS

The proposed action is covered by the current Board-adopted budget, and is affordable within the agency's current long-term financial plan and subarea financial capacity. The action will have no new revenue impacts on Sound Transit.

Prime Consultant/Contractor

The Sound Transit Diversity Programs Office established the following goals for this contract in the solicitation for bids: 18% of the Total Bid Price for Small Business participation, which was to be accomplished utilizing M/W/DBE participation of at least 12%. The commitment made by Kiewit Pacific Company in its bid submittal is as follows: 18.23% for Small Business,14.34% of which is to be performed by M/W/DBE firms.

As a result of the bid evaluation, with countersigned Letters of Intent reflecting the participation as agreed to between the listed firms and Kiewit Pacific Company (direct subcontracting), or its subcontractors (2nd-tier subcontracting), the following breakdown is presented. Sound Transit advertised for bids for Contract C700 simultaneously with advertisement for Contract C810 (construction contract for the Operations and Maintenance Facility.) In establishing the bidding format, it was recognized that the contractor could likely gain efficiencies, if both construction contracts were awarded to the same contractor. Kiewit Pacific Company submitted the low bid for both contracts. It is anticipated that a joint contract award will reduce construction risk at the point of interface between the guideway and the Operations and Maintenance Facility site.

CONSEQUENCES OF DELAY

Delays in awarding this construction contract will mean missing part of the current construction season. This would produce potential delay to the start of Contract C810, the new Operations and Maintenance Facility, since there is corresponding, phased work by both contracts within the site of the Operations and Maintenance Facility.

REGIONAL PARTNERSHIP AND COOPERATION

Sound Transit has worked closely with the City of Seattle, the Washington State Department of Transportation (WSDOT) and King County – Metro Transit, in the final design and permitting for this contract. The light rail facilities are being constructed adjacent to Metro's E-3 Busway, with property approvals from WSDOT as underlying owner of the Metro Busway. In addition, the cooperation of Seattle City Light was important and has allowed critical construction milestones in relocating electrical facilities to be achieved.

PUBLIC INVOLVEMENT

Sound Transit has developed a program for keeping the SODO area businesses informed as early construction work was initiated. This very successful effort has included briefing at the SODO monthly meetings and project update flyers hand carried to nearby businesses.
