OBJECTIVE OF ACTION

To construct the Central Link Light Rail Operations and Maintenance Facility.

ACTION

Authorize the Chief Executive Officer to execute a contract with Kiewit Pacific Company for the construction of Contract C810 (Central Link Operations and Maintenance Facility) in the amount of \$53,998,000 with a 10% contingency of \$5,399,800 for a total authorized contract amount not to exceed \$59,397,800, subject to the execution of the Full Funding Grant Agreement.

KEY FEATURES

- This contract comprises the construction of the Operations and Maintenance Facility for Central Link on a 25-acre site west of Airport Way South and south of South Forest Street. The facility will include an administrative building, maintenance facilities, and a rail yard with a storage capacity for 40 light rail vehicles. The site can accommodate a future expansion for a fleet of up to 108 light rail vehicles.
- Award of this contract is subject to execution of the Full Funding Grant Agreement.
- Identifies Kiewit Pacific Company as the lowest responsive and responsible bidder.

BUDGET IMPACT SUMMARY

There are no budget impacts for this action.

BUDGET DISCUSSION

The proposed action authorizes execution of a contract with Kiewit Pacific Company for an amount not to exceed \$59,397,800 for the construction of the Central Link Operations and Maintenance Facility.

The total adopted capital budget for the Initial Segment is \$2.07 billion. Within that budget, \$68,254,000 has been set aside in the construction phase for C810 Operations and Maintenance Facility and associated equipment. Should the proposed action be approved, this budget element will have a remaining balance of \$8,856,200.

REVENUE, SUBAREA, AND FINANCIAL PLAN IMPACTS

The proposed action is covered by the current Board-adopted budget, and is affordable within the agency's current long-term financial plan and subarea financial capacity. The action will have no new revenue impacts on Sound Transit.

Kiewit Pacific Company submitted the low bid for both contracts. It is anticipated that a joint contract award will reduce construction risk at the point of interface between the guideway and the Operations and Maintenance Facility. With both contracts awarded to the same contractor, the risk of possible delays at this interface is diminished. Further, performance of both contracts by a single contractor may result in an earlier start of the construction of the Maintenance Base, causing this work to be more concurrent with the construction of the line section contract and thereby facilitating coordination between these related scopes of work.
