Chief Executive Officer's Report

Ms. Earl introduced Mr. Mike Orgachock, Security Officer with Wackenhut Security who works at the Sounder station in Sumner. She relayed to the committee members that on Wednesday, June 23, 2004, Mr. Ogorchock noticed two girls crossing the railroad tracks directly after a freight train passed. The girls didn't realize an Amtrak train would also be crossing soon. Officer Ogorchock ran towards the girls yelling and waving his hands and successfully got their

attention seconds before the oncoming train crossed the intersection. Ms. Earl stated that Sound Transit had honored Officer Ogorchock for his heroism during an agency staff meeting.

Discussion Items

<u>Update on the Regional Express Service Agreements with Transit Partners</u>

Mr. Marty Minkoff, Transportation Services Director; Ms. Agnes Govern, Sounder/Regional Express Capital Projects Director, and Mr. Fred Chun, Transportation Services Project Manager, briefed the Executive Committee on the Regional Transit Service Agreements (copy on file).

Mukilteo Commuter Rail Station

Mr. Galen Torneby, Project Manager, Sounder/Regional Express Capital Projects, presented the presentation on the Mukilteo Commuter Rail Station. He stated that staff was seeking direction from the Executive Committee to proceed with the design and construction of the station.

Mr. Sims said that it was worth conducting a feasibility study.

Mr. Phelps expressed concern with building a temporary station when there are still track issues. He stated that he was comfortable with conducting a feasibility study, but was worried about available budget.

Ms. Marshall pointed out that with approximately 50% of the ridership coming from Whidbey Island, staff should include in the study looking at the parking capacity at the Clinton Ferry Terminal.

Ms. Marshall asked for additional information on the noise issue for residents near I-90 before the action comes before the Board.

It was moved by Mr. Sims, seconded by Mr. Phelps, and carried by the unanimous vote of all Executive Committee members present that Motion No. M2004-63 be forwarded to the Board with a do-pass recommendation.

Resolution No. R2004-09 – Amending Sound Move to provide for two-way transit and HOV operations in the outer roadways of I-90 between Seattle and Bellevue and to select Alternative R-8A as the project to be built for the I-90 Two-Way Transit and HOV Project

It was moved by Ms. Marshall, seconded by Ms. Patterson, and carried by the unanimous vote of all Executive Committee members present that Resolution No. R2004-09 be forwarded to the Board with a do-pass recommendation.
