OBJECTIVE OF ACTION

To amend the contract with LTK Engineering Services to provide systems construction management services for five light rail engineering, manufacturing, and installation contracts: Light Rail Vehicles (Contract P801), Signal System (Contract C802), Communications System (Contract C803), Traction Power System (Contract C807), and Fare Collection Equipment (Contract C809).

<u>ACTION</u>

Authorizes the Chief Executive Officer to execute a contract amendment with LTK Engineering Services to provide systems construction management services for the Central Link Light Rail Project Initial Segment in the amount of \$15,420,184, with a 7% contingency of \$1,079,413, totaling \$16,499,597, for a new total authorized contract amount not to exceed \$48,805,451, and to extend the term of the contract through December 2009.

KEY FEATURES

- The scope of systems construction management services includes project management, resident engineering services, office engineering, inspection, change administration, systems engineering support, systems design support for civil construction contracts, diversity administration, systems integration, and start-up.
- An integrated Sound Transit/LTK systems construction management team will administer a total value of contracts of approximately \$250 million.
- The amendment is consistent with the original contract scope of systems services to be provided by LTK for Central Link.

BUDGET IMPACT SUMMARY

There is no action outside of the Board-adopted budget; there are no contingency funds required, no subarea impacts, or funding required from other parties other than what is already assumed in the financial plan.

BUDGET DISCUSSION

This action authorizes execution of a contract amendment with LTK Engineering Services to provide systems construction management services for the Central Link Light Rail Project Initial Segment in the amount of \$15,420,184, plus \$1,079,413 contingency for a revised total amount not to exceed \$48,805,451.

The adopted capital budget for the Initial Segment is \$2.07 billion. Within that budget, \$16,506,916 has been set aside for systems and vehicle construction management in the construction services phase. Should the proposed action be approved, the balance remaining for these budget items will be \$7,319.

REVENUE, SUBAREA, AND FINANCIAL PLAN IMPACTS

The proposed action is consistent with the current Board-adopted budget and is affordable within Sound Transit's current long-term financial plan and the subarea financial capacity. The action will have no new revenue impacts on Sound Transit.

HISTORY OF PROJECT

On December 15, 1997, Sound Transit advertised and issued a Request for Proposals (RFP) for Systems Preliminary Engineering Design Services for Phase I of the Central Link light rail project. The RFP provided notice that the contract may be amended in the future to include final design and construction management. The selection committee recommended Sound Transit pursue negotiations with LTK Engineering Services. On April 23, 1998, the Board authorized the Executive Director to execute a contract with LTK.

During 2001, Sound Transit re-examined the Central Link project and on September 27, 2001, the Sound Transit Board identified a 14-mile preferred initial segment to be constructed and operated from Convention Place Station in downtown Seattle to South 154th Street. The Board made the final decision on selecting the initial segment on November 29, 2001. Also, on September 27, 2001, the Board authorized staff to complete an 18- to 24-month supplemental EIS and design effort to analyze alternative routes to the north of the initial segment interim terminus at Convention Place.

On March 14, 2002, the Board authorized a contract amendment with LTK Engineering Services for systems final design for Central Link Initial Segment, conceptual and preliminary systems

design for North Link alternatives, and systems construction management, design support services during construction and start-up for Tacoma Link.

As the Tacoma Link and Central Link projects have advanced through the preliminary design, final design, and construction phases, the Board has authorized incremental amendments to the LTK contract to cover specific systems tasks. This approach has allowed staff to effectively inform the Board, maximize oversight of the contract, minimize costs, and respond more effectively to changing project conditions.

A motion of the Board of the Central Puget Sound Regional Transit Authority authorizing the Chief Executive Officer to execute a contract amendment with LTK Engineering Services to provide systems engineering construction management services for the Central Link Light Rail Project Initial Segment in the amount of \$15,420,184, with a 7% contingency of \$1,079,413, totaling \$16,499,597, for a new total authorized contract amount not to exceed \$48,805,451, and to extend the term of the contract through December 2009.

Background:
