The Six-Year Transit Development Plan and 2003 Annual Report is required by the State Department of Transportation in order to present an overview of public transportation investments within the State of Washington to the Washington State Legislature. This information is part of the state transit planning requirements for all public transit agencies. The six-year plan sets forth those projects of regional significance for inclusion in the transportation improvement program within that region.

Per criteria outlined in Section 35.58.2795 RCW, the Six-Year Transit Development Plan and 2003 Annual Report contributes to local comprehensive plans mandated in Section 36.70A.070(6) RCW, regional transportation plans authorized in Section 47.80.030 RCW, metropolitan transportation plans required in 23 CFR 450.322, the state Public Transportation Plan required in Section 47.06.110 RCW, and the statewide Multimodal Transportation Plan required in Section 47.06.040 RCW.

CONSEQUENCES OF DELAY

WSDOT's Public Transportation Programs office is obligated to provide the House and Senate Transportation Committees with a status report of approved plans by September 1, 2004. WSDOT then prepares the *Annual Summary of Public Transportation*, which provides uniform data to transit providers, the legislative transportation committees, and local and regional governments. A delay in Board approval will mean that Sound Transit information may not be available in WSDOT's report to the legislature and may not be included in the *Annual Summary*.

PUBLIC INVOLVEMENT

Per state law, at least one public hearing is required. A public hearing is scheduled for August 5, 2004.
