#### **ACTION**

Authorizes the Chief Executive Officer to execute a contract with Parametrix to provide construction and post construction aquatic resource monitoring services for the Tukwila Freeway Route Project of the Central Link Light Rail Initial Segment project in the amount of \$232,000, with a contingency of \$23,200, for a total authorized contract amount not to exceed \$255,200.

### **KEY FEATURES**

- All monitoring activities will ensure compliance with the Record of Decision from Federal Transit Administration (FTA) and environmental permits from the City of Tukwila, Washington Department of Fish and Wildlife (WDFW) and the Army Corps of Engineers.
- The scope of work for this project consists of:
  - Monitoring construction activities associated with the Central Link Light Rail Tukwila Freeway Route Project (C755) in the vicinity of wetlands, streams and buffers; and
  - Monitoring the restoration of all temporarily impacted wetlands, streams, and buffers within the C755 project; and
  - Conducting construction and post-construction monitoring of the compensatory mitigation project.

## **BUDGET IMPACT SUMMARY**

There is no action outside of the Board adopted budget; there are no contingency funds required, no subarea impacts, or funding required from other parties other than what is already assumed in the financial plan.

## **BUDGET DISCUSSION**

The proposed action would authorize execution of a contract with Parametrix to provide construction and post construction aquatic resource monitoring services for the C755 Project of the Central Link Light Rail Initial Segment for a total authorized contract amount not to exceed \$255,200.

The adopted 2005 lifetime capital budget for the Initial Segment is \$2.07 billion. Within that budget, \$3,420,000 has been set aside within the construction phase to provide environmental mitigation for the C755 Project. To date, \$646,000 has been committed against this line item. Should the proposed action be approved, there would be a remaining balance of \$2,518,800 for this budget line item.

# REVENUE, SUBAREA, AND FINANCIAL PLAN IMPACTS

The proposed action is consistent with the current Board adopted budget and is affordable within the agency's current long-term financial plan and subarea financial capacity. The action will have no new revenue impact on Sound Transit.

## M/W/DBE - SMALL BUSINESS PARTICIPATION

#### Prime Consultant/Contractor

Sound Transit determined that subcontracting portions of the work for this contract was unlikely due to the specific nature of the services needed. Therefore, proposers were not required to submit a plan for subcontracting.

Four firms, including one small business, were interviewed by the selection panel. Parametrix was selected as the top firm.

Parametrix is the prime consultant for this contract. Parametrix will perform 100% of the work.

### **EEO Commitment**

Parametrix workforce demographics are 43% women and 8% minorities.

#### **HISTORY OF PROJECT**

The Tukwila Freeway Route (C755) Project passes through an area with numerous wetlands and streams. To date, no other Central Link Light Rail construction contract has passed through similar sensitive aquatic environments. Further, as part of an FTA sponsored environmental management system development process, the Agency's Environmental Compliance Division is developing procedures for tracking the implementation of environmental commitments during construction. # **CONSEQUENCES OF DELAY**

Delay could result in the start of construction in the vicinity of sensitive environmental resources without an Environmental Compliance Division monitor in place. It is important to have environmental oversight over the establishment of construction limits in order to avoid potential problems during construction.
