## **PROJECT NAME**

Mountlake Terrace Freeway Station/236<sup>th</sup> SW Project.

## PROPOSED ACTION

Authorizes the chief executive officer to execute Agreement GCA 3536 Task Order with the Washington State Department of Transportation for final design services for the Mountlake Terrace Freeway Station/236<sup>th</sup> SW Project in the amount of \$3,434,749, with a 10% contingency of \$343,475, for a total authorized task order amount not to exceed \$3,778,224.

#### **KEY FEATURES of PROPOSED ACTION**

- Authorizes a task order with the Washington State Department of Transportation (WSDOT) to perform final design services to continue the Mountlake Terrace Freeway Station project.
- The task order authorizes WSDOT to enter into a separate consultant agreement for professional support services to complete final design. The authorization for WSDOT's portion of the task order is \$0.9 million and the consultant's portion is \$2.6 million, excluding the task order contingency of \$0.3 million.
- The task order amount exceeds the phase level budget by \$1.2 million. The 2006 Adopted Budget was developed before scoping for final design was complete.

## **BUDGET and FINANCIAL PLAN DISCUSSION**

The Adopted 2006 budget for this project is \$25,545,383. The Final Design phase budget is \$2,580,000; this action will leave a phase level budget shortfall of \$1,205,620. The project has contingency funds in the amount of \$2,080,394. Consistent with Sound Transit budget policies, the phase level shortfall will be covered by reallocating project contingency funds to the Final Design phase to align phase budget amounts with project phase activity. This change is reflected in the 2007 budget for the project.

This will leave a contingency phase balance of \$874,774 (3.4% of Adopted Project Budget) and the remaining project balance will be \$17,979,472.

#### PROJECT DESCRIPTION and BACKGROUND for PROPOSED ACTION

The Mountlake Terrace Freeway Station/236th SW project will provide a freeway transit station, in the I-5 median adjacent to the Mountlake Terrace Park-and-Ride lot at I-5 and 236<sup>th</sup> Street SW in the City of Mountlake Terrace. The station and access ramps will provide direct access to existing I-5 HOV lanes. The project also includes a pedestrian bridge to connect the existing Mountlake Terrace Park-and Ride to the proposed freeway station. The freeway station will support more efficient transit operations, allowing Sound Transit to serve Mountlake Terrace with express service. The preliminary engineering and environmental documentation phase (PE/ED) for the project has been completed. Environmental documentation covered for the State Environmental Policy Act (SEPA) and National Environmental Policy Act (NEPA) has been completed. A SEPA Environmental Checklist and Determination of Non-significance (DNS) were issued by Sound Transit and the WSDOT in May 2005. A NEPA Documented Categorical Exclusion (DCE) was approved by the Federal Transit Administration and the Federal Highway Administration in November 2005.

The inadequacy of the initial project budget (\$3.8 million) was recognized when the project was initiated. A project definition study conducted in 2001 estimated the cost to complete the project would significantly exceed the project budget. Subsequent PE/ED work (30% design level) resulted in a refined cost estimate. In June 2005 the Board authorized a transfer of \$20.15 million from the Snohomish Program Reserve to bring the project budget in line with the refined cost estimate. Since that time, WSDOT's estimate of the construction cost has increased along with an increase in the final design costs. The 2006 schedule for completing the project is also at risk.

Over the last year, staff has worked with the project management team, which includes representatives from the City of Mountlake Terrace, WSDOT, Community Transit and the project design consultant to develop specific strategies to best manage the remaining work. Key strategies to-date include scope refinement and reduction, early completion of storm water and geotechnical analysis to better inform the final design, as well as seeking funds from other sources. Several scope modifications have been identified and incorporated in the cost to complete the final design scope of work. Staff recently submitted a grant application requesting additional funding for the Mountlake Terrace Freeway Station. Recommendations for WSDOT's "Regional Mobility" grant program will be made in late November 2006 and final project selection decisions made by the state legislature scheduled for the spring of next year. If successful, the grant funds would be additive to the project budget.

At this time staff is proposing to move forward into final design with the scope reductions that have been identified to date. The design team will proceed to a 60% design level and develop a new construction cost estimate. As part of this process, recent fluctuations in the construction costs will be assessed in order to help determine if any additional scope reductions are required to keep the project within budget. Staff will return to the Sound Transit Finance Committee at that time to provide a project update.
