Resolution No. R2007-05 - Adopting the Sound Transit 2 Regional Transit System Plan for the Central Puget Sound, together with its related Appendices.

Mr. Brian McCartan, Executive Director of Finance and Information Technology, Mr. Ric Ilgenfritz, Executive Director of Office of Policy, Planning, and Public Affairs, and Sheila Dezarn, Acting Policy and Planning Officer gave an update on the Sound Transit 2 plan (ST2).

Mr. Ilgenfritz advised that the Puget Sound Regional Council Executive Board voted to confirm that the ST2 plan conforms with Destination 2030 and Vision 2020 at its meeting held earlier in the day. A formal letter will be sent to Sound Transit. He also advised that staff work has now been completed on the ST2 Plan.

Ms. Earl listed the final ST2 plan documents which fulfill requirements of state law:

Chair Ladenburg and Vice-Chair Marshall thanked Board members and staff for their work and spoke in favor of the resolution.

It was moved by Mr. Olson, seconded by Ms. Marshall, and carried by the unanimous vote of thirteen Board members present that Resolution No. R2007-05 be approved as presented.

Motion No. M2007-55 - Ratifying a contract with Magnetic Technologies Corporation for emergency procurement of a transformer to be designed, fabricated, and delivered to the Central Link Operations & Maintenance Facility in the amount of \$118,000, plus estimated use tax of \$10,502, for a total authorized contract amount not to exceed \$128,502

Steve Proctor, Link Systems Engineering Manager gave a staff presentation.

It was moved by Mr. Marin, seconded by Ms. Burleigh, and carried by the unanimous vote of all Board members present that Motion No. M2007-55 be approved as presented.
