PROJECT NAME

Services – Maintenance of Stations and Facilities

PROPOSED ACTION

Authorizes the chief executive officer to execute a contract amendment with Westover Corporation to (1) integrate the building automation systems for providing the heating, ventilation, air conditioning at the Central Link and Tacoma Link Operations and Maintenance Facilities with Union Station; and (2) expand the cardkey systems to eight additional doors between Union Station and the Tacoma Link Operations and Maintenance Facility, in the amount of \$21,206 for a new total authorized contract amount not to exceed \$213,756.

KEY FEATURES of PROPOSED ACTION

- The scope of work includes:
 - Integration of the building automation systems that control the heating, ventilation, air conditioning (HVAC) and cardkey security for the Central Link and Tacoma Link O&M facilities with those at Union Station
 - The addition of card readers to eight doors between Union Station and the Tacoma Link O&M facility to the existing cardkey system.
- The agreement provides that Sound Transit may at any time request Westover Corporation to perform additional work beyond the original scope of work. Compensation for the additional work will be negotiated by both parties.
- This action will lower costs by allowing staff to operate and maintain the building automation systems from a central location at Union Station for the Central Link and Tacoma Link O&M facilities and Union Station.

BUDGET IMPACT SUMMARY

There is no action outside of the Board-adopted budget; there are no contingency funds required, no subarea impacts, or funding required from other parties other than what is already assumed in the financial plan.

BUDGET and FINANCIAL PLAN DISCUSSION

The original contract with Westover Corporation was signed in 2006 in the amount of \$192,550 and expires on November 5, 2007. Through December 2006, a total of \$185,453 is either spent or committed on this contract. The proposed addition of \$21,206 would bring the contract total to \$213,756. For 2007, the combined Tacoma Link services and Transportation Services budget available to cover this contract is \$2,409,744, of which \$32,097 would be spent on this contract.

BUDGET TABLE

The proposed contract extension is funded through a combination of existing budgets for Tacoma Link and Transportation Services, which are located on pages 53 and 193 in the Proposed 2007 Budget book. The impact of this contract on the proposed future budgets is illustrated below:
